

## CHAPTER 291—S. F. No. 1361

*An act to appropriate money for the payment of certain soldier bonus claims.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Appropriation for soldiers bonus.**—So much money as may be necessary is hereby appropriated from any money in the state treasury not otherwise appropriated to pay the following amounts to the persons hereinafter named, to be available immediately where not otherwise stated:

CHAPTER 292—H. F. No. 196

*An act to amend the last paragraph of Laws 1919, Chapter 463, Section 12, Subdivision 13, relating to Sibley State Park.*

Be it enacted by the Legislature of the State of Minnesota:

"13. For the purchase of so much of section 2, township 121, range 35 west of fifth principal meridian, and of section 35, township 122, range 35 west of fifth principal meridian in Kandiyohi county, as the game and fish commissioner may deem desirable and necessary, to be set apart and dedicated forever to the people of the state for their use as a public park to be designated and known as "Sibley State Park" the general care and supervision of which shall be vested in the state game and fish commissioner until otherwise provided for, available 1920 only.....25,000.00
