tenance thereof, or who knowingly permits any premises or place owned, managed or controlled by him to become or remain a nuisance, shall be held to be aiding in such nuisance.

The term "wholesale druggist" as used in this act is hereby declared to mean one who in good faith deals in drugs, chemicals and medicines in large quantities and who sells such drugs, chemicals and medicines chiefly to retailers thereof, who in turn retail the same in small quantities to the consumers."

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 306-S. F. No. 958

An act to appropriate money for expenses of the state government and for other purposes and prescribing present and future regulations and limitations relative to, and the expenditure of certain portions thereof, including appropriations from the trunk highway fund to defray expenses for issuing licenses and collecting the monies therefor for the highway department by the secretary of state.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriations for state government.—The sums hereinafter set forth in the columns designated "Appropriations" or so much thereof as may be necessary, are hereby appropriated out of any money in the state treasury not otherwise appropriated for the purposes specified in the following sections of this act, to be available for the fiscal years indicated for each purpose. The figures "1931", "1932", and "1933" wherever used in this act shall mean that the appropriation, or appropriations listed thereunder shall be available for the year ending June 30, 1931, 1932, and 1933, respectively.

Sec. 31. Generator for heating plant. - The State Building Commission is hereby authorized to expend not to exceed \$60,000.-00 out of the moneys appropriated under the provision's of Chapter 309, Laws 1929, for a new generator to be installed in the heating plant, provided, however, if the moneys appropriated under the provisions of said Chapter 309, Laws 1929, are not sufficient to cover the cost thereof, any deficiency not exceeding \$60,000.00 is hereby appropriated from the General Revenue Fund for such purpose.

Sec. 32. Unexpended balances reappropriated.—Unexpended balances on June 30, 1931, in the several appropriations heretofore made to the departments and activities named in this act are hereby reappropriated and made available for the fiscal years ending June 30, 1932, and June 30, 1933, respectively, for the purposes for which such appropriations were made. Where an appropriation is made in this act and there remains a balance in a previous appropriation for the same purposes, such balance shall be added to and become a part of such appropriation, except as herein otherwise specifically provided.

- Sec. 33. Auditor and treasurer to pay inheritance taxes to counties.—The state auditor and state treasurer are hereby authorized to pay to the county treasuries of the several counties of the state on or before November 1, 1932 and 1933, the amounts due the respective counties as their share of the state inheritance tax under the provisions of Section 21-D, Chapter 209, General Laws 1911, and acts amendatory thereof.
- Sec. 34. Executive council may borrow money.—Whenever it becomes necessary in order to meet the current demands upon the revenue funds for the payment of appropriations, the executive council may, at any time, prior to June 30, 1933, make such agreement with banks or other corporations or persons as they may deem advisable and necessary to pay warrants issued against said revenue fund, pursuant to any such appropriation prior to the time when the money to meet such appropriation comes into the state treasury and whenever any warrants are so issued for the accommodation of the state, and paid, the money necessary to pay interest upon the amount of such warrants from the time when such payment was made until the money to redeem such warrants comes into the state treasury at the rate agreed upon by said executive council is hereby appropriated.
- Sec. 35. This act shall take effect and be in force from and after its passage.

CHAPTER 307-S. F. No. 978

An act to establish a public employes retirement fund, to authorize deductions from salaries therefor and the payment of annuities and benefits therefrom, to provide for the management of said fund by a retirement board, and to define the powers and duties of such board.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Definitions.**—That the following words and phrases as used in this act, unless a different meaning is plainly required by the context, shall have the following meaning:
