Be it enacted by the Legislature of the State of Minnesota:

Section 1. Open season for sunfish in Goodhue county.—The open season for the taking of sunfish in Goodhue County is hereby extended from the closing date of said season as now provided by Mason's Minnesota Statutes of 1927, Section 5573, as amended, to and including February 1 following.

Sec. 2. Law modified.—Mason's Minnesota Statutes of 1927, Section 5573, as amended, is hereby superseded, modified, and amended so far as may be necessary to give full force and effect to the provisions of this act.

## CHAPTER 335-H. F. No. 1487

An act to extend the time for closing the affairs and disposing of the property of certain corporations whose existence has been terminated by the expiration of their period of duration for more than three years, not including, however, corporations having power of eminent domain.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Period for closing corporation extended.—Where any corporation, other than a corporation having the power of eminent domain, whose existence has been terminated by the expiration of its period of duration as fixed by its charter, did not fully close its affairs and convey all its property within the period of three years succeeding the date of such termination, and where any such corporation has or claims or appears to have or claim any interest in or to any property, the time so limited by law for so closing its affairs and disposing of its property is hereby extended for two years from and after the passage of this Act, for the purpose of permitting any such corporation to close up its affairs and dispose of its property, and said extension hereby made shall also apply for the purpose of authorizing and permitting service of process in actions at law or in equity, and in order that any such corporation may prosecute and defend actions and be served with process therein.

- Sec. 2. Proceedings legalized.—Any and all conveyances of property by any such corporation or corporations, and any and all proceedings and actions, including the service of process against any such corporation or corporations, made or done during said extended period, are hereby legalized and made of the same force and effect as if the same had been done within the said three years succeeding the expiration of the charter of said corporation.
- Sec. 3. Not to affect pending actions.—This Act shall not affect any action or proceeding now pending.
- Sec. 4. This Act shall take effect and be in force from and after its passage.

## CHAPTER 336--H. F. No. 1543

An act to appropriate money for the payment of the salary of the lieutenant governor and the salary and mileage of members of the legislature and for the payment of the per diem of the officers and employees of and all other expenses of the legislature including payment of necessary supplies therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for legislative expense.—That the sum of \$25,000.00 or so much thereof as may be necessary, be and the same hereby is appropriated from the revenue fund for the payment of the salary of the Lieutenant Governor and the salary and mileage of the members of the Legislature and for the payment of the per diem of the officers and employes of, and all the other expenses of the Legislature, including payment of necessary supplies therefor; provided that the moneys so appropriated shall be used and expended as prescribed by the rules and joint rules of the respective bodies of the Legislature; and each such body is authorized to make payments for salaries and other expenses in conformity with its rules and joint rules and its regulations.
