

products, have been so high as to dictate their location elsewhere" and "the grain producer has had little choice but to sell at one price to the one market,"

AND WHEREAS, these conditions, now aggravated by a nationwide depression, suggest the immediate employment of labor and industry in the construction of public and reproductive works,

AND WHEREAS, the Shipstead-Mansfield bill, now pending in Congress, provides for an internal loan to supplement annual budget appropriations for the adequate financing of all river and harbor projects already adopted by Congress, thus effecting a material saving in the primary cost of these works, hastening the date of their completion and beneficial enjoyment, and providing immediate employment for idle labor, idle industry and idle capital,

NOW THEREFORE, BE IT RESOLVED, by the Senate of the State of Minnesota, the House of Representatives concurring, that the Congress of the United States be memorialized and urgently requested to enact this bill into law, and that our representatives in Congress be urged to support it and use all honorable means to procure its passage.

BE IT FURTHER RESOLVED, that a copy of this resolution, attested by the proper officers of both houses, be sent to the President of the United States, the Secretary of War, the presiding officers of the Senate and House of Representatives, and to each United States Senator and member of Congress from the State of Minnesota.

RESOLUTION No. 19—S. F. No. 1305

A joint resolution providing for the participation of the State of Minnesota in the celebration of the Sesquicentennial of the battle of Yorktown in October, 1931 and appropriating money therefor.

WHEREAS, the Congress of the United States has by appropriate legislation provided that the Sesquicentennial of the Battle of Yorktown shall be celebrated at Yorktown, Virginia, and throughout the United States in October, 1931, and has directed that the celebration at Yorktown shall extend from October 16 to 19, inclusive, and has secured the consent of the President of the United States to be present and make the celebration address on October 19, 1931; and

WHEREAS, the United States Yorktown Sesquicentennial Commission of the congress has invited the State of Minnesota to participate in this national celebration, and it is preeminently fitting that the state should participate therein;

THEREFORE BE IT RESOLVED, the House of Representatives concurring, that a commission to be known as the Minnesota Sesquicentennial Commission, composed of the governor, the president of the Senate, the speaker of the House, three members to be named by the Senate, and three members to be named by the House of Representatives, be appointed.

The commission hereby appointed shall use all proper means to secure the official presence and participation of representatives of the people of this state at this important celebration, and to cooperate with the various commissions appointed by congress, and their accredited agencies, to the end that this great event be properly acclaimed and preserved in the history of the nation.

The commission, furthermore, shall cooperate in the effort to have this great historical event celebrated throughout the cities, villages, hamlets, public and private schools of the state, and by all patriotic state societies, including the request that on Sunday, October 18, 1931, prayers of thanksgiving be offered in all churches and other places of public worship throughout the state for the *blessings of liberty and for the protection and guidance of Almighty God vouchsafed to this nation and its people.*

For the purpose of giving effect to this resolution and enabling the commission hereby appointed to carry out the provisions thereof, there is hereby appropriated out of any money in the treasury not otherwise appropriated the sum of \$2,000, or so much thereof as may be necessary, to be expended under the direction of the commission in payment of such necessary expenses as may be incurred in the discharge of its obligations hereunder.

RESOLUTION

WHEREAS, on the 18th day of April, 1931, the House of Representatives of the State of Minnesota duly passed H. F. No. 1456, a bill for an act to divide the State of Minnesota into nine Congressional districts; and

WHEREAS, on the 20th day of April, 1931, said H. F. No. 1456 was duly passed by the Senate of the State of Minnesota; and

WHEREAS, said bill is now in the possession of the House.

NOW THEREFORE BE IT RESOLVED, that the Chief Clerk of the House be and he is hereby directed to deposit for filing with the Secretary of State the enrolled copy of said H. F. No. 1456, said bill to become and remain part of the permanent records of the office of the Secretary of State.

HOUSE FILE No. 1456

An act to divide the state of Minnesota into nine Congressional districts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The State of Minnesota is hereby divided into nine Congressional districts, each of which is entitled to elect one representative to the Congress of the United States.

Sec. 2. The Counties of Houston, Fillmore, Winona, Wabasha, Olmsted, Mower, Dodge, Freeborn, Waseca, and Steele shall constitute the First Congressional District.

Sec. 3. The Counties of Blue Earth, Faribault, Martin, Watonwan, Brown, Cottonwood, Jackson, Nobles, Rock, Pipestone, Murray, Redwood, Lyon and Lincoln shall constitute the Second Congressional District.

Sec. 4. The Counties of Washington, McLeod, Sibley, Nicollet, LeSueur, Carver, Scott, Rice, Dakota, Goodhue, and the Fourth ward of the City of Minneapolis and the villages of Deephaven, Edina, Excelsior, Long Lake, Minnetonka Beach, St. Bonifacious, Island Park, Richfield, St. Louis Park, Tonka Bay, Wayzata, Hop-

kins, Maple Plain, Morningside, Mound, and the towns of Bloomington, Eden Prairie, Excelsior, Independence, Minnetonka, Minnetrista and Orono in Hennepin County shall constitute the Third Congressional District.

Sec. 5. The County of Ramsey shall constitute the Fourth Congressional District.

Sec. 6. The Town of St. Anthony in Hennepin County and the City of Minneapolis except the Third, Fourth and Tenth wards thereof shall constitute the Fifth Congressional District.

Sec. 7. The Counties of Anoka, Benton, Sherburne, Stearns, Morrison, Mille Lacs, Isanti, Chisago, Kanabec, Pine, Aitkin, Crow Wing, Cass, Todd, Hubbard and Wadena shall constitute the Sixth Congressional District.

Sec. 8. The Counties of Grant, Douglas, Traverse, Stevens, Pope, Big Stone, Swift, Lac qui Parle, Chippewa, Yellow Medicine, Renville, Kandiyohi, Meeker, Wright and the Villages of Dayton, Golden Valley, Hanover, Osseo, Rogers, Crystal, Robbinsdale, Brooklyn Center, that part of the Village of Rockford in Hennepin County, and the towns of Brooklyn, Champlin, Corcoran, Dayton, Greenwood, Hassan, Maple Grove, Medina and Plymouth in the County of Hennepin and the Third and Tenth wards of the City of Minneapolis, shall constitute the Seventh Congressional District.

Sec. 9. The Counties of Koochiching, Itasca, Carlton, St. Louis, Lake and Cook shall constitute the Eighth Congressional District.

Sec. 10. The Counties of Otter Tail, Wilkin, Clay, Becker, Mahnomon, Norman, Polk, Marshall, Red Lake, Pennington, Kittson, Roseau, Clearwater, Beltrami, and Lake of the Woods, shall constitute the Ninth Congressional District.

Sec. 11. All acts and parts of acts inconsistent herewith are hereby repealed.

Sec. 12. This act shall take effect and be in force from and after its passage.
