SESSION LAWS

after the date of termination of its corporate existence and on or before two years after the passage of this act, are hereby legalized and made of the same force and effect as if the same had been made or done within three years after the date of termination of its corporate existence.

This act shall not affect any action or proceeding Sec. 4. now pending.

340-479-6 An act to provide for the treatment in public sanatoria, at the expense of the state, of employees of those state institutions which are under the direction, supervision and control of the state board of control, who contract and/become ill from tuberculosis while so employed.

CHAPTER 116-H. F. No. 448 /

Be it enacted by the Legislature of the State of Minnesota:

Employees of state tuberculosis sanatoria to be Section 1. examined before beginning employment.-The Board of Control shall require of all new employees of state institutions under the Board of Control a clinical examination which shall include a physical examination, an X⁴ray examination of the lungs, and any additional special diagnostic tests for the detection of tuberculosis as set up in regulations of the State Board of Health in cooperation with the State Board of Control for the purpose of determining the presence of tuberculosis among new employees. The licensed physician and surgeon making the examination shall report in writing on a form set up by the Board of Control in cooperation with the State Board of Health to the superintendent of the institution the presence or absence of tuberculous infection and disease based upon the clinical examination.

Sec. 2. Infected employees to be treated. Whenever the State Board of Control finds and determines that any state employee has contracted and become ill from tuberculosis while employed in or at any state institution which is under the direction, supervision and control of said board, with the exception of the county sanatoria under the supervision of the Board of Control, and that such employee is in need of and requires treatment in a tuberculosis sanatorium, the Board of Control shall apply for admission of such employee to the state sanatorium for consumptives or some county tuberculosis sanatorium.

The board shall pay out of funds heretofore or hereafter appropriated for aid to or maintenance of county tuberculosis sanatoria, to the state sanatorium for consumptives or the county tuberculosis sanatorium where said patient may be received, the same fee for the maintenance and care of such person as is received by said state sanatorium for consumptives or said county tuberculosis sanatorium for the maintenance and treatment of a non-resident patient.

Sec. 3. Who are eligible.—Only said employees who have been in direct contact with known tuberculous patients in performance, of the duties assigned to them in said institutions shall be eligible for sanatorium treatment herein described.

CHAPTER 117-H. F. No. 434

An act to authorize recording certified copies of petitions, . decrees, and orders made pursuant to the Federal Bankruptcy Act of 1898, as amended by the Bankruptcy Act of 1938, so as to make Section 21 g thereof effective in this state.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Recording decrees in bankruptcy proceedings.— Whenever a petition for bankruptcy, or a decree of adjudication, or an order approving the trustee's bond is made, pursuant to the Federal Bankruptcy Act of 1898, as amended by the Bankruptcy Act of 1938, Chapter 575, 52 Statutes 840, Section 21 g, the bankrupt, trustee, receiver, custodian, referee, or any creditor may record a certified copy of the petition, decree, or order in the office of the register of deeds or in the office of the registrar of titles of any county in this state.
