the persons entitled thereto out of money in the funds in which the sum so paid was placed.

## CHAPTER 237—H. F. No. 1535

An act tegalizing certain proceedings for the acquisition of title to-land under the laws relating to-taxation and validating-the titles acquired thereby as against certain claimed defects in the posting of the notice of expiration of time for redemption.

Be-it-enacted-by-the-Logislature-of-the-State-of-Minnesota:

Section 1. Proceedings validated.—Any proceedings here-tofore taken for the acquisition of title to real property by the State of Minnesota under the laws of this State relating to taxation are hereby legalized and the title acquired thereby validated when such proceedings were in all respects properly taken and conducted except that in complying with the requirements for posted notice by the Auditor as provided by Laws 1935, Chapter 278, Section 8, instead of a single posted notice for all parcels, the Auditor made up separate posted notices, and there being so large a number of such notices that it would have been impractical to affix them to a wall, post, or bulletin board, the Auditor posted the said notices in his office by placing them in loose leaf binders, and by keeping and maintaining the said loose leaf binders on a counter in his office, subject to public inspection, and to which all who desired had access.

Sec. 2. Not to affect pending actions. The provisions of this Act shall not apply to any action now pending in any of the Courts of this State.

## CHAPTER 238-H. F. No. 1565

An act appropriating money for old age assistance and aid to dependent children, providing for a tax levy and the issuance and sale of certificates of indebtedness in anticipation of the collection of such taxes.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Appropriation for old age assistance.—There is hereby appropriated out of any moneys not otherwise appropriated the sum of \$803,000, to be immediately available and to be disbursed as provided in Chapter 95 of the Special Session Laws of 1935 and acts amendatory thereof, for the care, relief and support of the aged, and the further sum of \$218,000, to be immediately available and to be disbursed as provided in Chapter 438, Session Laws of Minnesota for 1937, for the care, relief and support of dependent children, said amounts to be made available as hereinafter authorized.
- State Auditor to sell certificates of indebtedness .--The state auditor is hereby authorized and directed to issue and sell at not less than par, certificates of indebtedness of the state in the aggregate amount of \$1,021,000, which certificates shall mature at such time as the auditor may determine, not exceeding however the time when funds shall be available for the payment thereof from the tax levy herein authorized. Such certificates shall bear such rate of interest not exceeding three per cent per annum, payable semi-annually, and shall be in such sum as the state auditor may determine and shall be signed by the state treasurer and attested by the state auditor under their official seals, and the auditor and the treasurer shall keep a due record of each thereof. The proceeds of the sale of said certificates shall be credited to general revenue funds for the purposes of said appropriation, and said certificates and the interest thereon shall be paid from said fund, provided that such interest as may become due on said certificates until said taxes have been collected to meet the same shall be paid out of the revenue fund and the amount necessary therefor for such purposes is hereby appropriated.
- Sec. 3. Tax levy to retire certificates.—The state auditor is hereby authorized and directed to cause to be levied upon all taxable property in the state in the manner in which other taxes are levied for the taxable years of 1940, 1941, 1942 and 1943, a tax sufficient to produce the sums of \$255,250 for each of the said taxable years, together with such additional sums as may be necessary to pay the interest upon the certificates of indebtedness issued in pursuance to the provisions of this act.
- Sec. 4. Proceeds to general revenue fund.—The proceeds of such tax levy shall be credited to the general revenue fund and the same are hereby appropriated for the purpose of paying

the certificates of indebtedness authorized by this act, together with the interest thereon.

## CHAPTER 239-S. F. No. 1446

An act enabling certain villages to issue bonds for the purpose of completion of construction of a sewage disposal plant now under construction where original appropriations and funds set aside for that purpose are inadequate to complete such project.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Certain villages may issue bonds to complete sewage disposal plants.—The village council of any village now or hereafter having a population in excess of 10,000 inhabitants that has heretofore undertaken the construction of a sewage disposal plant with the aid of the Federal Government through PWA Administration, which plant is now in the process of construction, and found that the available funds set aside for that purpose are inadequate and insufficient to complete the said project as planned and contemplated unless additional funds are for that purpose available, is hereby authorized to issue bonds of such village to raise sufficient funds to complete such project; provided, however, that the aggregate face value of the bonds which are to be issued by any village under the provisions of this Act shall not exceed 15 % of the cost of said entire project and in no event the sum of **\$**50,000.00.
- Sec. 2. May be sold to state or private party.—Such bonds may be issued to the State or sold upon competitive bids. They shall be issued in such manner and with such interest rate and maturities as are prescribed by law, except that they may be issued by resolution adopted by the affirmative vote of all the members of the Village Council without approval by the voters of such village.

Section 3. This Act shall take effect and be in force from and after its passage.
