

CHAPTER 108—S. F. No. 484

An act relating to the printing and distribution of the legislative manual; amending Minnesota Statutes 1945, Section 5.08, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 5.08, Subdivision 2, is amended to read as follows:

5.08. **Legislative manual. Subd. 2. Distribution.** 15,000 copies of the legislative manual shall be printed and distributed as follows:

- (1) 50 copies to the president of the Senate;
- (2) 25 copies shall be available to each member of the legislature on request;
- (3) 50 copies to the state historical society;
- (4) 25 copies to the state university;
- (5) 60 copies to the state library;
- (6) Two copies each to the library of Congress, the Minnesota Soldiers' home, the state teachers colleges, the state high schools, the public academies, seminaries, and colleges of the state, and the free public libraries of the state;
- (7) One copy each to the state institutions not hereinbefore mentioned, the elective state officials, the appointed heads of departments, the officers and employees of the legislature, the justices of the supreme court, the judges of the district court, the senators and representatives in Congress from this state, and the county auditors;
- (8) One copy to each public school, to be distributed through the county superintendent of schools; and
- (9) The remainder may be disposed of as the secretary of state deems best.

CHAPTER 109—S. F. No. 522

An act relating to payment of claims by counties engaged in constructing, maintaining, or improving roads; amending Minnesota Statutes 1945, Section 162.18, Subdivision 3.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 162.18, Subdivision 3, is amended to read as follows :

162.18. **Payment of labor.** Subd. 3. **Issuance of time checks.** Any overseer, superintendent, or foreman so authorized shall, on the fifteenth and last days of each calendar month, issue to all persons who have performed manual labor in the carrying on of such work, or who have furnished tractors, trucks, teams, wagons, plows, scrapers, or other equipment, a time check, so called, for all labor performed by the person to whom the same is issued for labor on the road designated, or for the hire of tractors, trucks, teams, wagons, plows or scrapers and any and all equipment used upon the road work specified therein, prior to the date of issuance of same, and as to which no time check has been previously issued.

CHAPTER 110—S. F. No. 525

An act relating to procuring election supplies and instructions in making election returns, and amending Minnesota Statutes 1945, Section 205.40.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 205.40, is amended to read as follows :

205.40. **Auditor to send out election supplies.** The auditor shall, at least one week before every state election, send by registered mail, *insured parcel post*, express or deliver in person to the clerk of each town, each village that is separated from the town for election purposes, and each city in his county, and to the judges of election districts created and established out of territory in such county not organized into towns the necessary copies of each of such blanks and forms as are required in preparation for the conduct of such election, printed instructions to voters, together with two copies of the law relating to elections for each election district, also sufficient quantities of the necessary official ballots, ballot boxes, registers, and other supplies and materials so that such clerks and the judges of such election districts may comply with the provisions of chapters 200 to 212.
