CHAPTER 13—H. F. No. 43 [Not Coded]

An act to authorize city councils of cities of the second class not operating under a home rule charter to appoint city assessors and deputy assessors.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Assessor and deputy; appointment (Winona). In all cities of the second class not operating under a home rule charter the assessor and deputy assessors shall be appointed by the city council on the third Monday in April of each year hereafter, for a term of one year, commencing May 1 of each year hereafter.

Sec. 2. Effective date. This act shall take effect and be in force from and after its passage and after the expiration of the term of the assessor now in office.

CHAPTER 14—H. F. No. 44 [Not Coded]

An act establishing the term of office of all treasurers of all cities of the second class not operating under a home rule charter.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. City treasurer; election of (Winona). In all cities of the second class not operating under a home rule charter at the city election held on the first Monday in April in the year of 1949 and at each city election held on the first Monday in April quadrennially thereafter there shall be elected a treasurer to serve for a term of four years.

CHAPTER 15-H. F. No. 164

An act relating to the employment of minors; amending Minnesota Statutes 1945, Section 181.32.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 181.32, is amended to read as follows:

Child over 14, and under 16 years; employment 181.32. certificate. It shall be unlawful for any person, firm, or corporation to employ, permit or suffer, any child over 14, and under 16, years of age to work in any business or service during which the public schools of the district in which the child resides are in session, unless the employer procures and keeps accessible to the truant officer of the town or city. and to the Commission an employment certificate, as herein prescribed, and a list of all such children employed. On termination of the employment of a child such certificate shall be forthwith surrendered by the employer to the official who issued the same. Upon the request of any minor or employer, the person authorized to issue employment certificates shall issue to any minor 16 years of age or over an age certificate, upon presentation of the same proof of age as is required for issuance of an employment certificate. Such age and employment certificates when duly issued shall be prima facie evidence of the age of the minor as to any act which occurs after its issuance.

CHAPTER 16—H. F. No. 228 [Not Coded]

An act authorizing the council of certain cities to provide for the payment in installments of assessments for the construction of sidewalks.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Installment payments of special assessments (Waseca). The Council of any city of the fourth class operating under a home rule charter now or hereafter having more than 4,000 and less than 4,500 inhabitants now or hereafter located in a county containing not less than 12 nor more than 13 full or fractional congressional townships, may provide for the levying of special assessments for the construction, reconstruction, or repair of any sidewalk under the provisions of its charter, and further provides that such assessments may be paid in equal installments extending over a period of not less than five nor more than fifteen years.
