the county in which the sanatorium is located as a trust any gift, bequest, grant, or devise of property, both real and personal, from any source, whether subject to the special provisions of the donors or not. The proceeds derived from the sale of any property so acquired, and all gifts of cash, shall be placed to the credit of the tuberculosis sanatorium fund in the treasury of the county in which the sanatorium is located, and shall be disbursed as provided for under section 376.31.

Subd. 2. May accept gift from certain other counties. The county sanatorium commission is empowered to accept from any county not a part of the sanatorium district when the district was first organized but joining the district after its organization, any sum of money agreed to by the commission and said county, and place the money in a separate building fund to be used for the construction of new buildings and furtherance of the new building program of the district. In consideration of the payment of such money from the county to the commission, the county making the payment shall have such interest in all the lands, buildings, equipment and all other assets forming a part of and used in connection with the operation of the sanatorium in such district as may be agreed upon between said commission and said county.

Any such agreements entered into and any such payments made pursuant thereto prior to the passage of this act, are hereby validated, ratified and confirmed to the same extent as though made and entered into subsequent to its passage.

CHAPTER 350—S. F. No. 931 [Coded as Section 192.265, Subdivisions 1, 2, 3]

An act providing for retention of employee status of persons serving in certain military organizations, and providing for enforcement.

Be it enacted by the Legislature of the State of Minnesota:

[192.265] Status while in military training. Section 1. Subdivision 1. Period of training deemed absence with leave and without pay. Any person who is a duly qualified member of the Organized Reserve Corps of the United States, or of the Enlisted Reserve Corps of the United States, Minnesota

National Guard, Naval, Coast Guard, Marine Reserve, who, in order to receive military training with the Armed Forces of the United States, not to exceed two weeks in any one calendar year, leaves a position, other than a temporary position, in the employ of any employer, and who shall give evidence of the satisfactory completion of such training, and who is still qualified to perform the duties of such position, shall be entitled to be restored to his previous or a similar position, in the same status, pay, and seniority, and such period of absence for military training shall be construed as an absence with leave and without pay.

- Sec. 2. Subd. 2. Not to affect normal vacation and other privileges. Such absence for military training will in no wise affect the employee's right to receive normal vacation, sick leave, bonus, advancement, and other advantages of his employment normally to be anticipated in his particular position.
- Sec. 3. Subd. 3. Choice of relief in case of disobedience. In the event of the failure of any employer to comply with the foregoing, the employee may, at his election, bring an action at law for damages for such non-compliance, or apply to the District Court for such equitable relief as may be just and proper under the circumstances.

CHAPTER 351—S. F. No. 940 [Coded as Section 312.33]

An act relating to voluntary dissolution of certain corporations.

Be it enacted by the Legislature of the State of Minnesota:

[312.33] Dissolution of certain corporations. Section 1. Any corporation organized under revised Laws 1905, Chapter 58, and all acts amendatory thereto, relating to corporations for the purpose of aiding sick or distressed members of the Royal League, or any fraternal insurance organization, may be dissolved by complying with the provisions of Minnesota Statutes 1945, Sections 301.45 to 301.56, inclusive. Such corporations having no shareholders, the directors thereof
