enlarging of the site thereof, but in no case shall an annual levy in excess of such one mill be made therefor without authority conferred by a vote of the voters of said county.

Sec. 2. Levy not to exceed 4.25 mills. The county sanatorium commission shall determine by resolution each year prior to July first, the amount of money necessary for the maintenance of such sanatorium during the following year, and a certified copy of such resolution shall be forthwith forwarded to the board of county commissioners for approval, and such board shall, at the regular meeting in July, include the amount which it approved in the annual levy of county taxes. In no case shall the amount of such levy in any one year exceed 4.25 mills on the dollar of assessed valuation.

Sec. 3. Limitation on tax levy for all purposes. In no case the total levy made for all purposes as expressed in sections 1 and 2 in any one year exceed 4.75 mills on the assessed valuation, without authority conferred by a vote of the voters of said county.

## CHAPTER 599—S. F. No. 1422 [Not Coded]

An act to appropriate money for state department of education, state educational institutions, including University of Minnesota, University agricultural schools and experiment stations, teachers' colleges, aid to high, graded and rural schools, and to distressed school districts, certain appropriations for experiments and investigations, aid to agricultural agents and for other purposes; prescribing present and future regulations relative to the expenditure of certain portions thereof, and conferring upon the Board of Regents of the University of Minnesota the power of eminent domain in certain cases.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriations for educational purposes. Except as herein otherwise provided, the sums hereinafter set forth in the columns designated "APPROPRIATIONS," or so much thereof as may be necessary, are hereby appropriated out of the general revenue fund in the state treasury for the

purposes specified in the following sections of this act, to be available for the fiscal years indicated for each purpose. The figures "1947", "1948", and "1949" wherever used in this act, shall mean that the appropriation or appropriations listed thereunder shall be available for the year ending June 30, 1947, 1948 and 1949, respectively.

Sec. 2. State University, University farm school and experiment schools and stations:

Provided, that from the above appropriation, all nonacademic employees shall be paid a salary comparable to the salaries paid to state employees in the classified state civil service.

Provided, that from the above appropriation, \$276,000 each year is for salary increases for the non-academic employees of the University, and \$1,096,000 is for salary increases for the academic staff of said University, from which amount a 15 per cent increase in salaries to all academic staff of the University shall be made on July 1, 1947, and the balance of said amount is to be used in the further adjustment of the academic salaries by the Presiand the Board dent of Regents.

Provided, that the above apappropriation includes the sum of \$200,000 for each fiscal year for supplies, expense and salaries of academic staff and

other employees necessary for the opening of a Veterinary College at the University of Minnesota in the fall quarter of 1947.

Provided, further, that the Board of Regents of the University may use any money not specifically appropriated for other purposes for acquiring land by purchase or condemnation. In case it is desired to use the fund for the acquisition of land, the power of eminent domain may be exercised either in accordance with the General Statutes 1894, Sections 4085 to 4091 inclusive, or Revised Laws 1905, Chapter 41.

The University of Minnesota may establish and conduct a school for the instruction of persons in law enforcement, and the governing body of any political subdivision of this state may authorize the attendance upon such school of any law enforcement officer under its jurisdiction and may provide for the payment of the expenses of such person while in attendance at such school from the general funds of such political subdivision. To each person satisfactorily completing the prescribed course of instruction in the school as established shall be issued a certificate of graduation or diploma stating that the holder has graduated therefrom.

Provided, that out of the appropriation herein provided

there shall be furnished, without cost to the State Department of Health, maintenance and custodial care for the State Board of Health Psychology Building on the main campus of the University. Provided, further, that the amount of \$7,248 of the above appropriation is for ore estimates to be furnished by the School of Mines at the University of Minnesota, for the Department of Taxation.

Sec. 3. For care of indigent county patients to be rendered by the University in the University of Minnesota Hospitals, under Laws 1921, Chapter 411, Section 7, as amended:

1. For state's share of expense of county indigent patients...\$ 454,000

Provided, that from the above appropriations, all nonacademic employees shall be paid a salary comparable to the salaries paid to state employees in the classified state civil service.

Of the amounts appropriated above, \$29,000 in each year is for salary increases for non-academic employees.

A. Item 1 shall include and cover the amounts which may become due to the University of Minnesota from the state during the fiscal years covered by said Item under the provisions of General Laws 1921, Chapter 411, as amended by General Laws 1927, Chapter 431. There is further appropriated to the University of Minnesota the sum of \$454,-000 or so much thereof as may

be necessary, for the purpose of reimbursing the said University for the sum due from counties during said fiscal years under the provisions of said acts, payment to be made quarterly out of said appropriation, as shown by certificates filed with the state auditor pursuant to the provisions of said act.

The state auditor is au-B. thorized and directed to pay the University out of sums collected from counties under the provisions of Laws 1927. Chapter 431, during the fiscal years ending June 30, 1946, and June 30, 1947, respectively, an amount sufficient to reimburse said University in full for the amount due it from counties during said fiscal years, as shown by certificates filed with the state auditor, and a sum sufficient to make such payments is hereby appropriated.

Sec. 4. For various experiments and investigation to be carried on under the direct supervision of the University of Minnesota:

1. For the continuation of soil experiments and demonstrations in different parts of the state, under the direct charge of the Minnesota Experiment Station; and for making soil surveys in certain counties in Minnesota and for accompanying field experiments in the fertilization and management of soils to produce the most profitable crop returns, under the direct 1044 '

Sec. 9. Special appropriation to certain counties. Subdivision 1. There is hereby appropriated out of any moneys in the state treasury not otherwise appropriated the sum of \$19,000 payable July 1, 1947, and \$19,000 payable July 1, 1948, to each county now or hereafter having not less than 50 nor more than 55 whole or fractional congressional townships in which 45 per cent or more of the area therein is within a federal or state forest area.

Subd. 2. There is further hereby appropriated out of any money in the state treasury not otherwise appropriated the sum of \$29,000 payable July 1, 1947, and \$29,000 payable July 1, 1948, to each county now or hereafter having not less than 60 or more than 65 whole or fractional congressional townships, and in which 85 per cent or more of the area therein is within a federal or state forest area.

Subd. 3. The money appropriated by subdivisions 1 and 2 shall be paid to the county treasurer by the state treasurer on the warrant of the state auditor, one-half of such money to be placed in such county funds as the county board may direct and the other half to be paid by the county treasurer to the various school districts of the respective counties as follows:

(1) One-half thereof in the proportion that the federal or state lands within each district bear to the total area of federal and state lands within such county.

(2) The other one-half in the proportion that the average school attendance within each district bears to the total average school attendance of such county for the year last preceding such payment.

Subd. 4. The money appropriated by this section is not to be deducted from other forms of state aid to such counties and the school districts therein, but is in addition thereto.

Sec. 10. Unobligated balances. Except the revolving loan fund for maintenance of crippled children and other disabled persons receiving vocational training, and the revolving fund for the On the Job Training Program, the unobligated balances on hand as of June 30, 1947, June 30, 1948, and June 30, 1949, in the several appropriations and accounts for which an appropriation is made herein, unless otherwise excepted in this act, are hereby cancelled into the general revenue fund for the fiscal years ending June 30, 1947, June 30, 1948, and June 30, 1949.

Sec. 11. Receipts deposited for general revenue fund; exceptions. Except as herein otherwise specifically provided,

except income from swamp land trust fund, and except the income to the University of Minnesota and the income to the account of disabled persons receiving vocational training, and except all federal aid, contributions or reimbursements received for any account of any division, institution or department for which an appropriation is made in this act, all income, including fees or receipts of any nature whatsoever, shall be deposited in and for the benefit of the general revenue fund.

## CHAPTER 600-H. F. No. 631

An act relating to unemployment compensation amending Minnesota Statutes 1945, Section 268.06, Subdivision 20, Section 268.10, Subdivision 4, Section 268.11, Subdivision 3, Section 268.12, Subdivisions 3, 5, and 6, and adding to Section 268.12 new matter as Subdivision 14.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 268.10, Subdivision 4, is amended to read as follows:

268.10. Claims for benefits. Subd. 4. Appeal tribunals. In order to assure the prompt disposition of all claims for benefits, the director shall establish one or more impartial appeal tribunals consisting of a salaried examiner who shall serve as chairman, and two additional members, one of whom shall be a representative of employers and the other of whom shall be a representative of employees; each of the latter two members shall serve at the pleasure of the director and be paid a fee of not more than \$15.00 per day of active service on such tribunal plus necessary expense. The director shall by regulation prescribe the procedure by which such appeal tribunals may hear and decide disputed claims, subject to appeal to the director. No person shall participate on behalf of the director in any case in which he is an interested party. The director may designate alternates to serve in the absence or disqualification of any member of an appeal tribunal. The chairman shall act alone in the absence or disqualification of any other member and his alternates. In no case shall a hearing before an appeal tribunal proceed unless the chairman of such tribunal is present. There shall
