

of Europe have been prevented from finding in Palestine the home which had been promised to them by 52 nations of the world, including the United States of America; and

WHEREAS, the attainment of a just peace and the maintenance of a peaceful world requires a righteous and equitable settlement of the Palestine question to the end that the hundreds of thousands of homeless Jews of Europe may, as of right, be afforded the opportunity to enter Palestine and there re-establish the Jewish Commonwealth; and

WHEREAS, the United Nations, at the request of Great Britain as the mandatory power, is convening a special session of its General Assembly to consider the Palestine matter on April 28, 1947;

NOW, THEREFORE, BE IT RESOLVED by the House of Representatives of the State of Minnesota, the Senate concurring therein, that the Government of the United States, through the State Department and the President, direct our representatives in the United Nations to support the long established and officially declared policy of our Government favoring the establishment of the Jewish National Home in Palestine and the immediate opening of the doors of Palestine to large Jewish immigration.

BE IT FURTHER RESOLVED that copies of this resolution be sent to the President of the United States, the Secretary of State, the Senate and the House of Representatives of the United States of America.

RESOLUTION No. 19—HOUSE CONCURRENT

RESOLUTION No. 1586

A concurrent resolution memorializing the Congress of the United States to speed action in appropriating funds for the improvement of Red Lake River and tributaries in Clearwater, Red Lake and Pennington Counties, Minnesota.

WHEREAS, unprecedented flood conditions along the Red River of the North and tributaries are at this very time inundating thousands of acres of farm land, flooding cities and disrupting sewage, water supply and other public utilities,

and removing from crop production, hay, pasture and feed for livestock, hundreds of farms within the area, and

WHEREAS, the United States Corps of Engineers, War Department, have completed plans and have approved, in its report to Congress contained in House Document No. 345, 78th Congress, 1st Session, on "Red Lake River and Tributaries Including Clearwater River", dated October 25, 1943, a plan of flood control for these streams, and

WHEREAS, local affected interests have already subscribed to all of the conditions for participation in the project set forth in said report, and

WHEREAS, the actual commencement of construction awaits action by the Congress to appropriate the necessary funds.

NOW THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF MINNESOTA, THE HOUSE OF REPRESENTATIVES CONCURRING,

That the Congress is respectfully urged to appropriate immediately the necessary funds to enable the United States Corps of Engineers to undertake the flood control project outlined and recorded in House Document No. 345, 78th Congress, 1st Session, hereinbefore referred to, so as to prevent the recurrence of the disastrous floods which at present are devastating agriculture, municipalities and industries within the area.

BE IT FURTHER RESOLVED that a duly authenticated copy of this resolution be transmitted to the President of the United States, to the presiding officers of the Senate and House of Representatives of the Congress of the United States, and to each of the Senators and Representatives of the State of Minnesota in the Congress of the United States.

RESOLUTION No. 29

Memorializing the Congress of the United States to appropriate funds for the Mississippi Flood Control in Aitkin County.

WHEREAS, the Mississippi River makes a sharp bend in Aitkin County, which is 23½ miles around, and only six miles across from one point in the river to the other; and
