## CHAPTER 519-S. F. No. 379

An act relating to compensation for election services; amending Minnesota Statutes 1945, Section 200.35, as amended by Laws 1947, Chapter 499.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1945, Section 200.35, as amended by Laws 1947, Chapter 499, is amended to read:
- 200.35. Compensation for election services. The compensation for services performed under Chapters 200 to 212 shall be as follows:
- (1) To presidential electors, \$10.00 for each day's attendance at the capitol, and five cents for each mile necessarily traveled in going to and returning from St. Paul;
- (2) To persons carrying ballots from, and returns to, county auditor's offices, \$1.00 for each trip necessarily made, and five cents for each mile of necessary travel;
- (3) To members of county canvassing boards, \$5.00 for each eight hours of service as members of such canvassing board, and five cents for each mile of necessary travel;
- (4) To regular, special and ballot judges and clerks of election, not to exceed 75 cents for each hour necessarily spent in receiving votes or in counting and canvassing ballots; in the case of organized townships the compensation of judges and clerks shall be fixed at the annual meeting; in the case of unorganized territory by the county board; and in the case of villages and boroughs, by the governing bodies thereof, all subject to the limitations hereof; such compensation to regular, special and ballot judges and clerks of election in cities shall be fixed and determined by the council of such cities respectively; and

(5) To special peace officers, not to exceed 60 cents for each hour of service rendered by direction of the judges, the amount to be fixed as in the case of the judges and clerks of election.

## CHAPTER 520-S. F. No. 654

## [Not Coded]

An act fixing the salary of certain officials in cities of the first class now or hereafter having a population of 450,000 inhabitants, or over.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of mayor of Minneapolis. In cities of the first class now or hereafter having 450,000 inhabitants, or over, the salary of the following officials shall be as hereinafter set forth. Said salaries shall be payable pro rata monthly, out of the city treasury.

Mayor ..... \$9,000 per annum

Each alderman not to exceed \$4,200 per annum, which salary shall be in lieu of any allowance or reimbursement of automotive travel.

- Sec. 2. Additional compensation for service on boards. In addition to the salary fixed in Section 1 hereof, any of the above named officials who is or may become a member of a board or commission created by charter or statute, and who is allowed compensation for his service as such member, shall be entitled to such compensation in addition to the salary set forth in Section 1 hereof.
- Sec. 3. Retirement allowance. The fixing of the salary of any such official by the passage of this act shall not deprive him from participation in any retirement fund when such participation was, prior to the passage of this act, contingent upon a maximum salary less than that fixed herein.
