

CHAPTER 524—S. F. No. 832

An act relating to public lands and the sale thereof in conservation areas; amending Minnesota Statutes 1945, Section 282.19, as amended.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 282.19, as amended by Laws 1947, Chapter 484, Section 2, is amended to read :

282.19. County treasurer to collect payments. The county treasurer shall collect all payments made under Sections 282.14 to 282.22 and place the same in a special fund and forthwith submit to the conservation commissioner a copy of the receipt specifying the name and address of the person making the payment and the date and amount thereof, whether for principal, timber, improvements or interest, the fund to which it is applicable, and the number of the certificate. Such receipt shall be countersigned by the auditor of such county, and shall have the same force and effect as if given by the state treasurer. The county treasurer shall report all collections to the commissioner of conservation on June 30 and December 31 of each year and at such other times when requested by the commissioner. There shall be transferred from such special fund to the revenue fund of the county the cost of giving the notices herein required and there shall be paid from such fund to the members of the county board, upon warrant of the county auditor, \$3.00 per day for each day necessarily consumed in the classification and appraisal of the lands under Sections 282.14 to 282.22 and mileage at the rate of six cents per mile for necessary travel, and to the county auditor and the county treasurer for their additional duties such sums as the county board may by resolution determine, not to exceed to each annually one per cent of the annual receipts under Sections 282.14 to 282.22, inclusive, *and to help to defray the costs of equipment and supplies*, and for additional clerk hire in the county auditor's office such amount as the county board may by resolution determine, not to exceed annually 10 per cent of the annual receipts under Sections 282.14 to 282.22, inclusive, *but in any event not to exceed the sum of \$1,000 for equipment, supplies and clerk hire in any fiscal year.* Where a county board has appointed a land commissioner under the provisions of Section 282.13 the actual expenses of the land commissioner, together with mileage at the rate of six cents per mile for

necessary travel in gathering data and information to assist the county board in making classifications and appraisals under Sections 282.14 to 282.22, shall be paid from this fund upon warrant of the county auditor. The amount remaining in the fund shall be transmitted by the county treasurer to the commissioner of conservation as of June 30 and December 31 each year, and at such other times when requested by the commissioner, and disposed of as provided by the laws governing the fund derived from the respective areas in which the lands sold were situated.

CHAPTER 525—S. F. No. 847

An act relating to the legislature, providing for the compensation and mileage of the members thereof, and amending Minnesota Statutes 1945, Section 3.10.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 3.10, is amended to read as follows :

3.10. Compensation and mileage of members. The compensation of a member of the House of Representatives of the Legislature of the State of Minnesota shall be \$2,000 for the entire term to which *he is* elected, *which shall be due on the first day of the regular legislative session of the term and payable as follows: \$500 on the first day of February, \$500 on the first day of March, \$500 on the first day of April of the year in which the regular legislative session is held, and \$500 on the last day of the regular legislative session; the compensation of a Senator of the Legislature shall be \$4,000 for the entire term to which he is elected, of which \$2,000 shall be due on the first day of each regular legislative session of the term and payable as follows: \$500 on the first day of February, \$500 on the first day of March and \$500 on the first day of April of each year in which a regular legislative session is held, and \$500 on the last day of such regular legislative session, unless he shall die during a regular legislative session, in which event the balance due shall be paid forthwith as hereinafter provided. The balance of compensation due upon death of a Senator shall*
