and the officers of the fund shall biennially have made an actuarial study of the fund, the cost of which shall be borne by the fund. Reports on the actuarial survey shall be furnished to the legislature.

## CHAPTER 610-H. F. No. 1000

[Not Coded]

An act fixing the salaries of county commissioners in counties now or hereafter having a population of not less than 39,500 and not more than 42,000 and having an assessed valuation of not less than \$19,000,000.00 and not more than \$25,000,000.00 and containing within its boundaries a city of the third class.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Salaries of county board in certain counties. In each county of this state, now or hereafter having a population of not less than 39,500 and not more than 42,000, and having an assessed valuation of not less than \$19,000,000.00 and not more than \$25,000,000,00 and containing within its boundaries a city of the third class, the salaries of the county commissioners shall be \$1,500.00 per year, payable in equal monthly installments.
- Sec. 2. Payment validated. Any payments heretofore made in any such counties are hereby validated and approved.
- Sec. 3. Effective date. This act shall take effect and be in force thirty days from and after its passage.

## CHAPTER 611—H. F. No. 1180

[Coded as Section 43.23, Subd. 5]

An act relating to seniority rights of state employees in the classified service, amending Minnesota Statutes 1945, Section 43.23, by adding a new subdivision. Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 43.23, is amended by adding a new subdivision:

43.23. Seniority rights. [Subd. 5] Military service. In determining seniority rights of any state employee who held a position in the classified service and became separated therefrom to enter military service, and who was honorably discharged therefrom and reentered state service within six months thereafter, full credit shall be given for all state service prior to such military service.

- Section 1. Minnesota Statutes 1945, Section 130.04, is amended to read:
- 130.04. State board of education to issue certificates. The authority to certify teachers is vested in the state board of education. Certificates shall be issued to such persons as the board finds to be physically competent and morally fit to teach. Qualifications of teachers and other professional employees shall be determined by the state board of education under rules which it promulgates. Certificates of qualifications of teachers shall be issued by the Commissioner of Education.

- 130.15. Outstanding certificates not impaired. No provision or regulation adopted by the state board of education shall affect the validity of certificates or licenses to teach in
