

Subd. 2. The money hereby appropriated shall be used only for maintenance.

Subd. 3. No school district with an assessed valuation of \$1,300 or more per pupil in average daily attendance shall receive any aid under the provisions of this act.

Subd. 4. The state auditor shall supply to each county auditor plats with checkings thereon indicating the location and description of such lands situated within the school districts of the county.

[128.235] Sec. 2. **Appropriations; distribution by state auditor.** There is hereby annually appropriated from the state income tax fund \$100,000 to be distributed by the state auditor under the terms hereof, and in the event that said sum shall be insufficient to pay the full amount to which said school districts shall be entitled hereunder, the state auditor shall apportion said sum pro rata to each of said school districts.

CHAPTER 649—S. F. No. 1292

[Coded as Section 98.46]

An act relating to protected wild animals and to licenses pertaining thereto, and amending Laws 1949, Chapter 150, Section 18, Subdivisions 2 and 15.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1949, Chapter 150, Section 18, Subdivision 2, is amended to read as follows:

[98.46] **License fees.** Subd. 2. Fees for the following licenses, to be issued to residents only, shall be:

- (1) To take small game, \$2.00;
- (2) To take deer with firearms and bow and arrows, \$3.50;

(3) To take fish *by angling*, \$1.50;

(4) Sportsmen's license, to include the *privilege of taking small game, fish by angling, deer with firearms and bow and arrows, and spearing fish from a dark house*, \$8.50, plus any additional fee the licensee, at his option, desires to pay;

(5) Combination husband and wife, to take fish *by angling*, \$2.00;

(6) To take moose, \$5.25.

Sec. 2. Laws 1949, Chapter 18, Subdivision 15, is amended to read as follows:

Subd. 15. Fees for the following licenses, to be issued to non-residents, shall be:

(1) To take fish *by angling*, \$4.00;

Sec. 3. **Effective date.** The provisions of this act relating to an increase in the license fee to be issued to residents only for the purpose of taking fish by angling and for an increase in the resident license fee for a combination license issued to husband and wife to take fish by angling, and the provisions relating to increasing the non-resident license fee to take fish by angling, shall take effect January 1, 1950.
