SESSION LAWS

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County auditor; salary. That in all counties having more than 300,000 and less than 450,000 inhabitants the county auditor shall be paid \$4,500.00 per annum.

Sec. 2. Deputies; appointment of. Such auditors may appoint and employ one chief deputy and 30 deputies pursuant to the civil service laws relating to such county and the rules and regulations made pursuant thereto.

Sec. 3. Chief deputy; salary. Such chief deputy and deputies shall receive the salary fixed by the board of county commissioners.

Sec. 4. Additional employees. The board of county commissioners may authorize the employment of such additional employees as it believes necessary.

CHAPTER 66-H. F. No. 290

An act providing for the election and term of office of abstract clerks in all counties having a population of more than 300,000 and less than 450,000 inhabitants; amending Laws 1945, Chapter 54, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1945, Chapter 54, Sections 1 and 2, is amended to read:

Section 1. Ramsey county; election of Abstract clerk. In all counties having more than 300,000 and less than 450,-000 inhabitants, an abstract clerk shall be elected at the general election for county officers to be held in the year 1950 and each four years thereafter, and his term of office shall be for four years and until his successor is elected and shall have qualified.

Sec. 2. Continuance in office of incumbent. The abstract clerk now in office in any county embraced in Section one of this act, shall hold office until his successor has been elected at the general election in the year 1950 and until such successor has qualified as provided by law.

CHAPTER 67-H. F. No. 291

An act relating to the salaries of the coroner and his employees in counties having more than 300,000 and less than 450,000 inhabitants; amending Laws 1941, Chapter 241, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That Laws 1941, Chapter 241, Section 1, be amended to read:

Section 1. Ramsey county; salary of coroner and deputies. In all counties of this state having *more than 300,000* and less than 450,000 inhabitants, the coroner shall be a duly licensed and practicing physician and surgeon and the salary of the coroner shall be \$4,000 annually.

Section 2. That Laws 1941, Chapter 241, Section 2, be amended to read:

Sec. 2. Ramsey county; appointment and salary of deputy coroners. The coroner of all such counties shall appoint a chief deputy coroner, and such other deputy coroners as he may deem necessary, a secretary, and assistant secretary and a morgue keeper. The compensation of the chief deputy coroner, of the secretary, of the assistant secretary, and of the morgue keeper shall be fixed by the Board of County Commissioners, and their employment shall be pursuant to such civil service laws as may be in force in said county.
