

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 508.32 is amended to read:

508.32 Under control of court; affixing seal. The registrar of titles shall be at all times under the control of the court, which may adopt such rules governing the conduct of his office as it may deem wise. Every registrar of titles shall have an official seal and affix the same to all documents requiring his official signature. *Provided, however, that instead of affixing his said official seal to certificates of title he may use a printed facsimile thereof at all points in said certificate where his official seal is required.*

CHAPTER 73—H. F. No. 596

An act to grant to the executive council power to extend certain timber permits upon the recommendation of the conservation commissioner.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Executive council; extension of timber permits. The executive council, upon application of the holders of any incompleated permits issued August 1, 1940, September 11, 1940, August 15, 1941, September 18, 1941, October 22, 1941, June 19, 1942, September 16, 1942, September 17, 1942, September 22, 1942, September 21, 1943, September 22, 1943, September 24, 1943, December 8, 1943, and August 2, 1944, may for good and sufficient reason and upon the recommendation of the conservation commissioner, extend the same for and during such period as the council deems advisable.

Sec. 2. Interest. Any permit extended under the provisions of this act shall be subject to the charge of six per cent per annum interest on the entire unpaid purchase price and the destruction of the timber by any cause during the period of such extension shall not relieve the purchaser for

payment of the same, and said purchaser shall be liable to the state therefor as provided for in Minnesota Statutes 1945, Section 90.07.

CHAPTER 74—H. F. No. 649

An act relating to the salary of the clerk of court in counties having more than 300,000 and less than 450,000 inhabitants, and to the number of his deputies; amending Minnesota Statutes 1945, Section 485.015.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. That Minnesota Statutes 1945, Section 485.015, be amended to read :

485.015. Ramsey county; salary of district court clerks. The salary of the clerk of the district court of each county in this state having *more than 300,000 and less than 450,000* inhabitants shall be the sum of \$4,500 per annum.

Such clerk of the district court may appoint and employ one chief deputy *and thirteen deputies in addition to the juvenile court deputy provided by Minnesota Statutes 1945, Section 260.04. The appointment and employment of deputies other than the chief deputy shall be pursuant to the laws establishing civil service in such county.*

CHAPTER 75—H. F. No. 653

An act to fix the salary of the county attorney and to fix number of assistants and employees in the office of the county attorney in any county having more than 250,000 and less than 450,000 inhabitants; amending Laws 1945, Chapter 471, Section 4.
