

CHAPTER 82—H. F. No. 271

An act authorizing the conveyance of certain real estate owned by the state to the city of Hopkins.

Be it enacted by the Legislature of the State of Minnesota:

Section. 1. State conveyance to city of Hopkins. Notwithstanding any law to the contrary, the governor upon the recommendation of the commissioner of highways shall transfer and convey by proper deed of conveyance, in the name of and on behalf of the State of Minnesota, to the city of Hopkins in the county of Hennepin for public purposes, all or any portion or portions of the following described real estate situated in Hennepin County, Minnesota, to-wit:

That part of the southeast quarter of the northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of section 24, Township 117 north, range 22 west, described as follows:

Beginning at a point distant 36 feet north and 278.19 feet east of the intersection of the east line of 5th Avenue in the Village (now city) of Hopkins, according to the plat thereof now on file and of record in the office of the Register of Deeds of Hennepin County, with the south line of said southeast quarter of the northeast quarter of section 24; thence run northerly to a point on the south line of State Aid Road No. 18, as same was located and traveled over and across said southeast quarter of the northeast quarter of section 24 on December 13, 1937, (said road also being known as Mills Road), distant 285.15 feet southeasterly (when measured along said south line of road) of its intersection with said east line of 5th Avenue; thence run southeasterly along said south line of State Aid Road No. 18 to its intersection with a line run parallel with and distant 940 feet east of the west line of said southeast quarter of northeast quarter of section 24; thence run southerly along said 940 feet parallel line to the south line of said southeast quarter of the northeast quarter of section 24; thence run westerly along said south line of said southeast quarter of the northeast quarter of section 24, for a distance of 228.81 feet; thence

run northerly parallel with the west line of said southeast quarter of the northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of section 24 for 36 feet; thence run westerly for 400 feet, more or less, to the point of beginning:

containing 6.36 acres, more or less.

Sec. 2. Payment to state. The consideration to be paid by the City of Hopkins to the State of Minnesota for any real estate conveyed hereunder shall be in such amount and subject to such terms and conditions as may be mutually agreed upon by the city and the commissioner of highways.

CHAPTER 83—H. F. No. 534

An act relating to the manufacture and sale of concentrated commercial feeding stuffs, and amending Minnesota Statutes 1945, Section 25.03.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 25.03, is amended to read as follows:

25.03. Statement affixed to packages and samples. Subdivision 1. **Tags and labels.** Any person, company, corporation, or agent who shall sell, offer or expose for sale or distribution in this state any concentrated commercial feeding stuffs shall affix, or cause to be affixed, to every package or sample of such concentrated commercial feeding stuffs, *except as provided in subd. 2 hereof*, in a conspicuous place on the outside thereof, a tag or label, which shall be accepted as a guarantee of the manufacturer, importer, dealer, or agent, and which shall have plainly printed thereon, in the English language, the number of net pounds of concentrated commercial feeding stuffs in the package, the name, brand, or trademark under which the concentrated commercial feeding stuffs are sold, the name of the manufacturer, the location of the principal office of the manufacturer, and the guaranteed analysis, stating minimum percentage of crude fat and crude protein, and the maximum percentage of crude fiber, determined
