praisers from the division of lands and minerals of the department of conservation, to convey to Lee E. Johnson by proper instrument attested by the state auditor a quit claim deed to a tract of land described as follows, to-wit:

The East 13.9 feet of the parcel of land lying and being in the County of Pope, State of Minnesota, described as follows, to-wit: Commencing at a point on the north line of Government Lot Five (5), Section Eleven (11), Township One Hundred Twenty-five (125), Range Thirty-eight (38), which is 838 feet west of the northeast corner of said government lot, thence running south 624.2 feet along a line that coincides with the fence on the westerly side of the property known as the State Fish Hatchery property, to the place of beginning, thence running west 150 feet on a line that is parallel with and 95 feet north of the north line of Bakke's Subdivision of a part of Government Lots Four (4) and Five (5) of said Section Eleven (11), thence running north about 143 feet to the south boundary line of Trunk Highway No. 28, thence running southeasterly along the south line of said highway to a line that is parallel with and 150 feet east of said west boundary line and running north to the highway, thence running south about 98 feet to the place of beginning, and subject to existing easements.

An act authorizing the governor and the state auditor to convey to Orpha Evjen a tract of land in Pope County, Minnesota; repealing Laws 1953, Chapter 93.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Conveyance of land to Orpha Evjen. The governor is hereby authorized and directed upon the recommendation of the commissioner of conservation and upon payment to the state auditor by said Orpha Evjen for said land, which amount shall be determined by one of the regular appraisers from the division of lands and minerals of the department of conservation, to convey to Orpha Evjen by proper instrument attested by the state auditor a quit claim deed to a tract of land described as follows, to-wit: That part of the following described tract of land which lies north of the North boundary of Trunk Highway No. 28: A tract of land in government lot five (5) of section eleven (11), township one hundred twenty-five (125), range thirtyeight (38), more particularly described as follows, to-wit: Commencing at a point on the North line of said government lot 838 feet West from the Northeast corner of said section, which said point is marked by an iron stake $\frac{3}{4}$ of an inch in diameter, and at which point the North line of said government lot is intersected by a fence on the Westerly side of the property known as the State Fish Hatchery, thence running South at a 90 degree angle to the North line of said government lot five (5) a distance of 719.2 feet to a point marked by an iron stake $\frac{3}{4}$ of an inch in diameter, thence running West 13.9 feet, thence running North to the North line of said government lot five (5), thence running East along the North line of said government lot to the place of beginning, subject to existing highways.

CHAPTER 412-S. F. No. 905

An act relating to the sale of certain property, real and personal, of the State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Commissioner of administration to sell certain property. Subdivision 1. The commissioner of administration is authorized and directed to offer for sale at public sale after two weeks' published notice in newspapers in Grand Rapids, Duluth and St. Paul, Minnesota, of general circulation, the real and personal property hereinafter described and payable as provided in Subdivision 3.

Subd. 2. The property referred to in Subdivision 1 is that tract or parcel of land lying and being in the County of St. Louis and State of Minnesota, described as follows:

All that part of the Southeast one-quarter of the Northwest one-quarter (SE^{1}_{4} of NW^{1}_{4}) of Section Twenty-Seven (27), Township Fifty-Two (52), North of Range Twenty-One (21), West of the Fourth Principal Meridian, according to the United States Government survey thereof.
