CHAPTER 421-S. F. No. 1341

An act relating to lands conveyed to the state for the storage of iron ore or other materials subject to reversion of title and amending Minnesota Statutes 1949, Section 93.20, as amended by Laws 1951, Chapter 616.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 93.20, Subdivision 28(3), as amended by Laws 1951, Chapter 616, is amended to read as follows:

(3) Land conveyed to the state upon condition that it shall be used for the storage of iron ore or rather materials having present or potential value belonging to the state, subject to termination or reversion of title when no longer needed or used for that purpose, shall be deemed suitable and available therefor. The commissioner may accept such a conveyance in behalf of the state if he shall determine that the conditions thereof conform with the foregoing provisions and will fully protect the interests of the state in the materials to be so stored, but no consideration shall be paid for such conveyance unless authorized by law. The provisions of Minnesota Statutes 1949, Section 500.20 shall not apply to any conveyance of land to the state pursuant to this subdivision and shall not limit the duration of any covenant, condition, restriction, or limitation created by any such conveyance.

CHAPTER 422-S F. No. 1351

An act relating to salaries of elected officials in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Anoka county, officers salary. In any county having a taxable valuation of over \$9,000,000 and less than \$13,000,000 exclusive of money or credits, and having over 35,000 inhabitants according to the 1950 census, the board of county commissioners may increase the salaries of the elective county officers in an amount not to exceed ten per cent above the amount provided by law and in effect on January 1, 1953.

Sec. 2. Increase of salary, termination or revocation. After the salary of any county officer has been increased under the provisions of this act the county board may revoke or terminate such increase at any time.

CHAPTER 423-S. F. No. 1379

An act relating to highway traffic regulations; amending Minnesota Statutes 1949, Section 169.67, Subdivision 4.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 169.67, Subdivision 4, is amended to read:

Subd. 4. Service brakes on all wheels. Every new motor vehicle, trailer, or semi-trailer, sold in this state and operated upon the highways shall be equipped with service brakes upon all wheels of every such vehicle, except that any motor-cycle, any semi-trailer of less than 1,000 pounds gross weight, a third wheel, of a swivel type, on a house trailer, a temporary auxiliary axel [axle] attached to a motor vehicle during the period of road restrictions for the purpose of relieving weight of another axel [axle] when the temporary auxiliary axel [axle] and the axel [axle] to be relieved do not exceed the combined gross weight of 18,000 pounds, and the vehicle to which such temporary axel [axle] is attached meets the brake requirements of this section, need not be equipped with brakes.

CHAPTER 424-S. F. No. 1410

An act relating to accumulation and disposition of rents and profits of real estate; amending Minnesota Statutes 1949, Section 500.17.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 500.17, is amended by adding a new subdivision to read:

Subd. 6. Inapplicable to accumulations of rents and profits of real estate held by trustee. The provisions of this section shall not apply to the accumulations of rents and profits of real estate held or owned by a Trustee or Trustees of a trust forming a part of a stock bonus, pension, retirement or profitsharing plan or fund exempt from tax under the provisions of
