the Internal Revenue Code of the United States, and rents and profits of real estate held or owned by any such Trustee or Trustees may be accumulated without restriction as to time.

CHAPTER 425—S. F. No. 1440

An act relating to salaries of town supervisor, assessor and treasurer in certain towns.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of officers of certain towns. In any town in this state now or hereafter having a population of not less than 1,000 and not more than 2,000, and consisting of two congressional townships and having an assessed valuation of not less than \$1,300,000 for the year 1952, in addition to all other powers and duties provided by law, the town board at any regular or special meeting shall have the power to fix the salary of:

(1) The town assessor at not less than \$400 nor more than \$630 per year;

(2) Each town supervisor at not less than \$25 nor more than \$50 per month;

(3) The town treasurer at not less than \$25 nor more than \$50 per month.

CHAPTER 426-S. F. No. 1453

[Not Coded]

An act relating to minimum annual salaries of county treasurers in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Dakota county, treasurer's salary. Subdivision 1. In all counties of this state with a population of not less than 48,500 nor more than 50,000 inhabitants, according to the 1950 federal census, the minimum annual salary of the county treasurer shall be \$5,000.

Subd. 2. The board of county commissioners of any such county may increase the minimum annual salary of the county treasurer in any amount which it shall consider proper but such increase shall not exceed \$1,000. When the board of county commissioners has increased the minimum annual salary of the county treasurer under the provisions of this act, it shall have the right to modify, revoke or terminate such increase at any time.

CHAPTER 427-S. F. No. 1654

An act relating to importing and raising and to the sale of frogs for human consumption.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [101.441] Frogs, permits for sale, import, and raising. The commissioner of conservation may issue permits for the importing, raising and sale of frogs for human consumption in the state of Minnesota under such regulations as he shall prescribe.

CHAPTER 428-H. F. No. 55

An act relating to powers of the board of any state teachers college; amending Minnesota Statutes 1949, Section 136.09.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 136.09, is amended to read:

136.09 **Degrees.** The state teachers college board shall have authority to award appropriate degrees to persons who complete the prescribed four-year curriculum of studies and the five year curriculum in teacher education in the state teachers colleges.
