CHAPTER 447-H. F. No. 1644

An act relating to the planting and destruction of aquatic vegetation in public waters; amending Minnesota Statutes 1949, Section 98.48, Subdivision 9.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 98.48, Subdivision 9, is amended to read:

Subd. 9. The commissioner may issue special permits, without fee, to gather or harvest any aquatic plants or bulbs other than wild rice from public waters of the state, to transplant the same into other public waters, or to destroy any harmful or undesirable aquatic vegetation or organisms in public waters by such means and under such conditions as he may prescribe for protection of such waters and desirable species of fish, vegetation, and other forms of aquatic life therein.

CHAPTER 448-H. F. No. 1683

An act relating to taxation by the City of Henderson; repealing Special Laws 1891, Chapter III, Sub-chapter V, Sections 2, 3.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Special Laws, 1891, Chapter III, Sub-chapter V, Sections 2, 3, are hereby repealed.

CHAPTER 449-H. F. No. 1700

[Not Coded]

An act relating to certain school districts having a population in excess of 10,000 and less than 20,000 and an assessed valuation in excess of \$20,000,000 and authorizing bonds for constructing, rebuilding, or rehabilitating schoolhouses and the levying of taxes therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain school district; bonds, tax levy; schoolhouses. Any school district now or hereafter having a population of more than 10,000 and less than 20,000, and an assessed valuation in excess of \$20,000,000 may issue and sell its bonds in the principal amount of not to exceed \$238,000 for the purpose of constructing, rebuilding or rehabilitating schoolhouses or additions thereto. Such bonds shall be issued and sold in the manner provided by law except that they may be authorized by a two-thirds vote of the members of the school board without the question being submitted to the electors of the district. The district may levy taxes for the payment of such bonds and interest thereon in excess of any existing limitations upon the tax levies of such district. The authority granted by this act shall be in addition to and not a limitation upon any other powers of the district with respect to the issuance and payment of bonds.

CHAPTER 450—H. F. No. 1701

An act relating to school districts having a population of more than 1,500 and less than 2,000, and an assessed valuation in excess of \$5,000,000 and less than \$10,000,000 and authorizing bonds for building purposes and tax levies therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain school district; bonds, tax levy; building purposes. Any school district now or hereafter having a population of more than 1,500 and less than 2,000, and an assessed valuation in excess of \$5,000,000 and less than \$10,000,-000, may issue and sell bonds in the principal amount of not to exceed \$25,000, for the purpose of constructing school buildings, including garages, or additions thereto. Such bonds shall be issued and sold in the manner provided by law except that they may be authorized by a majority vote of the members of the school board, without the question being submitted to the voters of the district. The district may levy taxes for the payment of such bonds, plus interest thereon, in excess of any existing limitations upon tax levies of such district.

Sec. 2. The authority granted by this act shall be in addition to and not a limitation upon any other power of the district with respect to the issuance and payment of bonds.
