tion of education beyond the borders of the State of Minnesota in exchange for services of a teacher with qualifications acceptable to the State Teachers College Board.

Sec. 3. [Subd. 3.] The exchange teacher shall retain all rights under contract with the State Teachers College Board as though teaching in a Minnesota State Teachers College.

CHAPTER 598-S. F. No. 1065

[Coded]

An act authorizing the State Teachers College Board to conduct classes in the several state teachers colleges on certain holidays.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [136.22] State teachers colleges, holding classes on holidays. The State Teachers College Board is hereby authorized to conduct classes in the several state teachers colleges on either or any of the following holidays: Lincoln's Birthday, Washington's Birthday, Columbus Day and Armistice Day, provided that when classes are held on Washington's Birthday, Lincoln's Birthday or Armistice Day, that at least one hour of the school day be devoted to a patriotic observance of that day.

CHAPTER 599-S. F. No. 1068

An act pertaining to student activity fees at state teachers colleges; amending Minnesota Statutes 1949, Section 136.11, Subdivision 4.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 136.11, Subdivision 4, is amended to read:

Subd. 4. Student activities. Student activities as the term is used in Laws 1943, Chapter 611, means lecture courses, concerts, and other functions contributing to the mental, moral and cultural development of the student body and community in which they live, athletic activities, including intercollegiate

contests, forensics, dramatics and such other activites of any nature as in the opinion of the state teachers college board contribute to the educational, cultural, or physical well being of the student body.

CHAPTER 600-S, F. No. 1097

[Coded in part]

An act relating to and requiring reduction in the amount of special state aids to be paid school districts in certain cases; amending Minnesota Statutes 1949, Section 128.05.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. [128.061] Special state aids, computation. The amount of special state aids to which a school district is entitled shall be the amount computed according to statute except as that amount may be reduced under this act. The certificate made by the Commissioner of Education under Minnesota Statutes 1949, Section 128.18, Subdivision 2, shall show the amount of any reductions made hereunder.
- Sec. 2. [128.062] Reduction in state aids, grounds. Whenever the school board of the district authorizes or permits within the district violations of law by
- 1. Employment in a public school of the district of a teacher who is not qualified as defined in Minnesota Statutes 1949, Section 120.03, or
- 2. Noncompliance with a mandatory rule or regulation of general application promulgated by the state board of education in accordance with statute in the absence of special cincumstances making enforcement thereof inequitable contrary to the best interest of, or imposing an extraordinary hardship on, the district affected, or
- 3. Continued performance by the district of a contract made under Minnesota Statutes 1949, Section 125.06, Subdivision 5 or Subdivision 14, which has been disapproved where time for review of the determination of disapproval has expired and no proceeding for review is pending, or
- 4. Any practice which is a violation of Section 3 of Article VIII of the Constitution of the State of Minnesota, or
- 5. Failure to provide reasonably for the school attendance to which a resident pupil is entitled under Minnesota
