

## CHAPTER 125—H. F. No. 393

*An act relating to the issuance of motor vehicle license plates; amending Minnesota Statutes 1961, Section 168.12, Subdivisions 3 and 4.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 168.12, Subdivision 3, is amended to read:

Subd. 3. **Motor vehicles, license plates, increase of fees and taxes.** All fees and taxes imposed upon any motor vehicle, any licensed dealer of motor vehicles, or any licensed drive-away contractors by sections 168.011 to ~~168.49~~ 168.65, the payment of which is required as a condition to the issuance of any pair of number plates, ~~numbers, tabs, or stickers~~ are hereby increased in the sum of 25 50 cents. If a single number plate, ~~number, tab, or sticker~~ is issued, the tax or fee imposed is hereby increased in the sum of 25 cents.

Sec. 2. Minnesota Statutes 1961, Section 168.12, Subdivision 4, is amended to read:

Subd. 4. **Fee increase; tax exempt plates.** All fees imposed by sections 168.011 to ~~168.49~~ 168.65 for the issuance of tax-exempt number plates or duplicate number plates are hereby increased in the sum of 25 50 cents. If a single number plate or a single duplicate number plate is issued the tax or fee is increased in the sum of 25 cents.

Sec. 3. *This act becomes effective November 15, 1963 for the year 1964 and subsequent years.*

## CHAPTER 126—H. F. No. 397

*An act relating to the salary of the county auditor of Nicollet county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Nicollet county; auditor's salary.** The county auditor of Nicollet county shall receive a yearly salary of not less than \$5,000 and not to exceed \$7,500.

Sec. 2. The county official herein referred to shall be entitled to and shall receive, in addition to the amount specified in section 1 hereof, all cost of living increases heretofore or hereafter allowed or allowable pursuant to the cost of living index as certified to the county auditor pursuant to Minnesota Statutes, Section 375.43.

Sec. 3. This act shall be effective upon approval by a majority vote of the members of the county board of Nicollet county, and upon compliance with Minnesota Statutes, Section 645.021, and shall be retroactive to January 1, 1963.

CHAPTER 127—H. F. No. 435

*An act relating to compensation of certain officials in Blue Earth county and the number of deputies and clerks for such offices and their compensation.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Blue Earth county officers' salaries.** The county of Blue Earth shall pay to each county official designated in this section as full compensation for all services rendered by them, annual salaries to be determined by the board of county commissioners, but not less than the amounts herein specified as due each official. The officials and the amounts specified are as follows:

1. County auditor	\$7200
2. County treasurer	7200
3. Sheriff	7200
4. Clerk of district court	7200
5. Register of deeds and registrar of titles, being one office	7200

Sec. 2. All fees collected by the county officials named in section 1 shall be paid to the county in the manner and at the times prescribed by the county board, and no such officials shall receive any such fees as additional compensation.

Sec. 3. The board of county commissioners shall by resolution determine the number of deputies assigned to each office, and
