the number of clerks and other employees required in the performance of each respective office, and shall determine and provide for the compensation of each.

- Sec. 4. Subdivision 1. The clerk of district court shall have the authority to appoint with the approval of the district court judge having chambers in the county a deputy clerk of district court and such clerks and other employees in the office as are assigned and required in the performance of the duties of the office as determined by the county board pursuant to section 3 of this act.
- Subd. 2. The sheriff shall have the authority to appoint deputy sheriffs and court bailiffs.
- Sec. 5. In addition to the salaries and compensation to be paid officials, deputies, clerks, and employees as provided in this act, the board of county commissioners shall by resolution provide for the payment of premiums of any bonds required of any official, deputy, clerk, or employee designated in this act.
- Sec. 6. This act as to compensation of the clerk of district court takes effect on January 1, 1965, and as to the auditor, treasurer, sheriff, and register of deeds on January 1, 1967.
- Sec. 7. All laws now in force relating to compensation or fees of the county officials named in this act inconsistent herewith are hereby repealed and superseded.
- Sec. 8. This act shall become effective only after its approval by a majority of the board of county commissioners of Blue Earth county, and upon compliance with Minnesota Statutes, Section 645.021.

## CHAPTER 128-H. F. No. 570

An act relating to annual salaries of the county auditor and county treasurer in Wilkin county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Wilkin county; auditor and treasurer; salaries. The board of county commissioners of Wilkin county shall set the annual salary of the county auditor at not less than \$5,500 and not

more than \$6,500, and the annual salary of the county treasurer at not less than \$5,200 and not more than \$6,200. The salaries, as determined by the board of county commissioners, shall be retroactive to January 1, 1963. These salaries shall be in addition to any fees.

- Sec. 2. The salaries as provided in section 1 may be adjusted as provided in Minnesota Statutes, Section 375.43.
- Sec. 3. This act is effective upon its approval by a majority of the members of the board of county commissioners of Wilkin county and upon compliance with Minnesota Statutes, Section 645.021.

## CHAPTER 129—H. F. No. 597

[Coded]

An act authorizing any city, village, borough, or town excepting cities of the first class to appropriate money to the county historical society and to levy taxes therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [138.053] County historical society; tax levy; cities, villages, boroughs, or towns. The governing body of any city, village, borough, or town excepting cities of the first class may appropriate annually an amount from its general fund of not to exceed one mill of the assessed value of the taxable property in the city, village, borough, or town, but not to exceed \$500, to be paid to the historical society of their respective county to be used for the promotion of historical work and to aid in defraying the expenses of carrying on the historical work in said county. No city, village, borough, or town may appropriate any funds for the benefit of any historical society unless such society shall be affiliated with and approved by the Minnesota historical society.
