In such elections in each succeeding odd numbered year, the number of directors shall be elected for four year terms corresponding to the terms expiring.
- Sec. 4. All such elections shall be held in the manner prescribed by law and the directors elected at each such election shall take office at the regular meeting of such school board meeting held in May next succeeding each such election.
- Sec. 5. The governing body of said special school district No. 3 and the city council of the city of Duluth shall apportion the cost of each such election in such proportion and amount as said bodies shall agree upon.
