

## CHAPTER 261—H. F. No. 1138

[Not Coded]

*An act authorizing the board of municipal works of the city of Winona to award certain contracts not exceeding \$1,500 without calling for bids.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Winona, city of; award of contracts.** The board of municipal works of the city of Winona may contract for materials or for any construction of any of the works under its control or for the expense of laying, relaying, enlarging, and repairing water mains for an amount not exceeding \$1,500 at any time without calling for bids. This section shall apply notwithstanding any other provision of the city charter of Winona or any other provision of state law.

Sec. 2. This act shall become effective only after its approval by a majority of the board of municipal works of the city of Winona and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 262—H. F. No. 1266

*An act relating to the town of West Lakeland in the county of Washington; conferring certain village powers.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **West Lakeland, town of; village powers.** The town of West Lakeland in Washington county shall have, in addition to all other powers now or hereafter vested in said town, like powers as are now or hereafter vested in villages as specified in Minnesota Statutes, Section 412.221, Subdivisions 3, 6, 8, 9, 11, 14, 16, 17, 18, 19, 20, 21, 22, 23, 25, 26, 28, 29, and 32, Section 412.111, Section 412.191, Subdivision 4; Sections 412.231, 412.491, 412.851, 412.871, 429.011 to 429.101, 465.01, and 471.62, as now in force or hereafter amended. The town board and the officers of said town shall have like powers and duties with respect to any of the powers so specified as the village council and the corresponding officers, respectively, of any such village.

Sec. 2. This act takes effect as to the town of West Lakeland in Washington county only after its approval by a majority of the town board of said town and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 263—S. F. No. 720

*An act relating to Anoka county; providing the undersheriff shall be in the unclassified service.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Anoka county; undersheriff.** Notwithstanding any provision of Minnesota Statutes, Sections 387.31 to 387.45, the office of the undersheriff in Anoka county shall be in the unclassified service.

Sec. 2. Section 1 is effective upon its approval by a majority of the members of the county board of Anoka county and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 264—S. F. No. 1399

*An act directing the sale of a building and land owned by the state of Minnesota and located in the city of Duluth.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state land; Duluth.** Subdivision 1. The commissioner of administration is directed to appraise and sell as provided by law lots 12 and 13, block 25, Endion Division of Duluth, St. Louis county, according to plat thereof on file and of record in the office of the register of deeds within and for said county, together with a warehouse, no longer used, located thereon.
