Sec. 5. The county board shall provide for payment of premiums of any bonds required of any official designated in section 1 or any employee of such official.

Sec. 6. This act shall become effective only after its approval by a majority of the members of the board of county commissioners of Dakota county and upon compliance with Minnesota Statutes 1961, Section 645.021.

CHAPTER 324—H. F. No. 1128

An act relating to Olmsted county; authorizing the county welfare board to pay certain salaries and expenses of assistant county attorney.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Olmsted county; welfare board; assistant county attorney. The county welfare board of Olmsted county is authorized to pay from welfare funds a share of the salary, clerk hire, and expenses of an assistant county attorney, such share to be proportionate to the expenses incurred on county welfare board matters and other county matters as determined by the county attorney.

Sec. 2. This act shall become effective only after its approval by a majority of the members of the board of county commissioners and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 325—H. F. No. 1132

An act authorizing the village of Annandale to issue general obligation bonds to fund debt heretofore incurred for water and sewer extension and street improvement.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Annandale, village of; improvement bonds. The village council of the village of Annandale is hereby authorized to issue and sell general obligation bonds of the village in the amount of not to exceed \$12,000 for the purpose of providing money to pay for water and sewer extension and street improvement. Such bonds shall mature in such years, bear such rate or rates of interest, and be sold in such manner as the village council shall by resolution determine.

Sec. 2. The proceeds of such bonds shall be used solely to pay for water and sewer extension and other improvements pursuant to contracts heretofore entered into by the village council and all such contracts are hereby legalized and validated.

Sec. 3. This act shall not apply to or affect any action or appeal now pending in which such bonds shall be called in question.

Sec. 4. This law is a special law and shall go into effect when approved by a majority of the village council of the village of Annandale, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 326-H. F. No. 1216

An act authorizing the county of Koochiching to require work relief as a condition to receiving assistance from the county; and authorizing such work relief on property or projects of the state or agency thereof.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County of Koochiching; authority to require work relief. The county of Koochiching may, as a condition for granting relief or public assistance to any person able and competent to work, require that such person perform work relief as provided herein.

Sec. 2. **Definition of work relief.** The term "work relief" means support or relief in wages or other compensation, in cash or in kind, paid for work under the following conditions: (a) That the recipients of work relief and the amounts given are both determined on the basis of actual need and certified for such work relief by the
