An act relating to St. Louis county; providing that the county welfare board shall assist certain schools to carry on nutrition programs; amending Laws 1943, Chapter 515, Section 1, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1943, Chapter 515, Section 1, as amended by Laws 1945, Chapter 87, Section 1, and Laws 1951, Chapter 234, Section 1, is amended to read:

Section 1. St. Louis county; appropriation to assist rural schools to provide lunches. In any St. Louis county with a population of 150,000 or more and an area of more than 5,000 square miles, the county welfare board may shall set aside \$20,000 per year from funds raised in the county for direct relief purposes to be used to assist the rural schools of the county to carry on a nutrition program in the schools and to provide hot lunches for needy school children in any independent, common, or unorganized school district which does not contain an incorporated city or village of more than 800 population. Any rural school which is in a consolidated school district and which, prior to such consolidation, was receiving such county assistance to carry on a nutrition program may shall continue to receive such assistance even though such consolidation had taken place with a district in which there is a village which has a population of 800 or more.

Sec. 2. This act shall become effective only after its approval by a majority vote of the members of the county board of St. Louis county, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 98.48, is amended by adding a new subdivision to read:

[Subd. 15.] Fish toxicants. The commissioner may issue special permits, without fee, to any individual, to any lake improvement association or group of riparian owners who have obtained the written consent of each and every riparian owner of the lake or pond affected, to apply fish toxicants to waters of the state for the purpose of reclamation at their own expense. The commissioner may, by posting, authorize the seasons, limits and methods of taking fish prior to the introduction of fish toxicants.

Section 1. **Plymouth municipal court; judge's salary.** The annual salary of the judge of the municipal court of Plymouth is \$4,200, commencing June 1, 1963, and \$4,900, commencing January 1, 1964, notwithstanding the provisions of Minnesota Statutes 1961, Section 488.21, Subdivision 2.

Sec. 2. The revisor of statutes in compiling the next edition of the Minnesota Statutes shall substitute the salary fixed in section 1 hereof for the salary specified for such judge in Minnesota Statutes 1961, Section 488.21, Subdivision 2.
