

CHAPTER 58—S. F. No. 126

An act granting the commissioner of conservation power to enter into agreements with the counties of Todd or Douglas or any municipality of the counties to improve and maintain a tract of land known as Battle Point for the benefit of the public.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Battle Point; improvement and maintenance. The commissioner of conservation is hereby granted power to enter into agreements with the county of Todd or Douglas or with any municipality of said counties to permit such counties or municipalities to improve and maintain for the benefit of the public for the purposes of fishing, hunting, picnicking, camping, playing of athletic games, access to the lake, and general recreational purposes, the following described lands located in Todd county: Commencing at the westerly corner of a triangular tract of land in section 5, township 128, range 35, designated as tract "A" of Michael's Subdivision of a portion of government lot 1, section 4, township 128, range 35, according to the recorded plat thereof, thence southwesterly, westerly and northwesterly, curving to the right along the shore of Lake Osakis, to the tip of Battle Point; thence southeasterly along the shore of Lake Osakis, to a point where the shore line intersects the north-south section line between sections 4 and 5 of township 128, range 35; thence north along said section line, between said sections 4 and 5 of township 128, range 35; to the southerly corner of the hereinbefore mentioned tract "A" of said Michael's Subdivision; thence northwesterly to the point of beginning known as Battle Point.

CHAPTER 59—S. F. No. 142

An act relating to factors liens; the renewal of the effective period of the lien; amending Minnesota Statutes 1961, Section 514.87.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 514.87, is amended to read:

514.87 Factors liens; payment; satisfaction; certificate; time limitation. Upon payment or satisfaction of the indebtedness secured by any factor's lien, the factor, upon the request of the

borrower, shall furnish to the borrower a certificate or certificates signed by the factor stating that such indebtedness has been paid or such lien satisfied, or both. When such certificate or certificates are filed with the officer with whom the original notice of lien has been filed, such lien shall be deemed discharged. Failure of the factor to deliver any such certificate or satisfaction within ten days after any such request shall subject the factor to double damages at the suit of any person injured by such neglect. All liens shall be deemed to have expired three years from the date of filing of the notice of creation thereof unless prior to the expiration of such three year period the factor files a statement under oath that the indebtedness secured by said factor's lien has not yet been paid in full or otherwise discharged, and upon the filing of such statement the said lien shall be deemed to continue for one year from the date of such filing or until the prior payment of the indebtedness but any such lien may be extended for successive additional periods of one year after such initial three year period, by filing with the officer with whom the original notice of lien has been filed, within 60 days next preceding the expiration of each period, an affidavit made by the factor stating that the indebtedness secured by such lien has not been paid in full or otherwise discharged.

CHAPTER 60—S. F. No. 200

An act relating to the use of railroad right of ways; repealing Minnesota Statutes 1961, Sections 230.01 through 230.08 inclusive.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Sections 230.01, 230.02, 230.03, 230.04, 230.05, 230.06, 230.07 and 230.08 are hereby repealed.
