

## CHAPTER 774—S. F. No. 1750

*An act relating to the county of Ramsey; authorizing the county board to contract for liability insurance.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Ramsey county; liability insurance.** The Board of County Commissioners of Ramsey County is authorized to enter and execute contracts with private insurance companies providing for insurance and indemnity involving liability of the County of Ramsey for negligent acts or omissions of its officers, agents or employees. Such insurance may be in such amounts and for such premium as the County Board may determine necessary to protect the public interests.

Sec. 2. This act shall take effect upon its approval by The Board of County Commissioners of Ramsey County, and upon compliance with Laws 1959, Chapter 368.

## CHAPTER 775—S. F. No. 1751

*An act relating to Ramsey county; prescribing certain duties for the county auditor; amending Minnesota Statutes 1961, Section 98.50, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 98.50, Subdivision 1 is amended to read:

98.50 **Ramsey county; auditor; hunting and fishing licenses; issuance.** Subdivision 1. County Auditors are hereby appointed agents of the commissioner for the sale of licenses to take big and small game and fish, and to trap fur-bearing animals, to residents of the state, and to take big and small game and fish, to non-residents of the state. Each county auditor may appoint sub-agents within his county to sell such licenses, and upon such appointment, the auditor shall notify the commissioner forthwith of the name and address of the sub-agent. Such appointments may be revoked by the auditor at any time and he may require such security of the agent as he deems advisable, and he shall revoke any agency upon demand of the commissioner. The county auditor shall be respon-

sible for all license blanks issued to, and license fees received by, his agents except *in Ramsey County* or in counties to which Laws 1951, Chapter 381 applies. In such ~~county~~ *counties* the responsibility imposed above upon the county auditor is imposed upon the ~~county~~ *counties*.

Section 2. *This Act becomes effective upon approval by the Board of County Commissioners of Ramsey County, and upon compliance with Laws of 1959, Chapter 368.*

CHAPTER 776—S. F. No. 1785

*An act relating to fees of the sheriff in Ramsey county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Ramsey county; service of process; sheriff's fee.** In Ramsey County the sheriff shall charge a fee of One Dollar for receiving, indexing and putting in line for service each summons and complaint left with him for service. Such fee shall be in addition to any other fees now provided by law, and shall be absorbed by the plaintiff in the action. It shall not be charged to the defendant nor taxed as costs against him in the action or any proceedings ancillary thereto.

Sec. 2. This act shall take effect upon its approval by the Board of County Commissioners of Ramsey County, and upon compliance with Laws 1959, Chapter 368.
