(1) That such child's bodily or mental condition is such as to prevent his attendance at school or application to study for the period required: or

That such child has already completed the studies ordi-(2) narily required in the tenth grade; or

(3) That it is the wish of the parent, guardian, or other person having control of such child, that he attend for a period or periods not exceeding in the aggregate three hours in any week, a school for religious instruction conducted and maintained by some church. or association of churches, or any Sunday school association incorporated under the laws of this state, or any auxiliary thereof, such school to be conducted and maintained in a place other than a public school building, and in no event, in whole or in part, at public expense; provided, that a child may be absent from school on such days as the child attends upon instruction according to the ordinances of some church.

Provided that students in regular attendance at the University of Minnesota Northwest School of Agriculture at Crookston, Minnesota, and the University of Minnesota Southern School of Agriculture at Waseca, Minnesota; during the fall and winter terms may be excused from attendance between April 1 and October 1 in any year.

. The clerk or any authorized officer of the school board shall issue and keep a record of such excuses, under such rules as the board may from time to time establish-

Sec. 2. Minnesota Statutes 1967, Section 120.10, is amended by adding a subdivision to read:

Subd. 4. Issuing and reporting excuses. The clerk or any authorized officer of the school board shall issue and keep a record of such excuses, under such rules as the board may from time to time establish. Each excuse issued shall state the reason for such excuse and a copy of each excuse issued under section 1, subdivision 3, clause (1) shall be forwarded to the commissioner of education within 30 days following issuance.

CHAPTER 162-H. F. No. 874 An act relating to agriculture; membership of the poultry improvement board; amending Minnesota Statutes 1967, Section 29.011.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 29.011, is amended to read:

poultry improvement board: 29.011 Agriculture: For the purpose of fostering the development of the membership. poultry industry of the state, particularly through the improvement of breed type and productiveness of poultry flocks and through the control and eradication of infectious and communicable diseases, and for the further purpose of improving the marketing of poultry and poultry products, and of affording protection to buyers of poultry breeding stock by providing and indicating dependable sources from which poultry may be purchased, there is hereby created a body to be known as the Minnesota poultry improvement board, which shall be constituted as follows: the chief of the poultry division of the college of agriculture, university of Minnesota, the secretary and executive officer of the state livestock sanitary board, one representative of the department of animal science of the institute of agriculture, university of Minnesota, whose primary concern is in the field of poultry, and six other members, who shall be competent and experienced poultrymen, one of whom shall be an owner and operator of a commercial poultry hatchery, one of whom shall be a turkey breeder, one of whom shall be a broiler producer, one of whom shall be a market egg producer, one of whom shall be a packer-processor of poultry and eggs, and one of whom shall be a poultry breeder, all of the latter six seven board members to be appointed by the governor, each for a term of three vears and until his successor qualified. This Minnesota poultry improvement board shall act in an advisory capacity with the commissioner of agriculture in carrying out the provisions of sections 29.021 to 29.091.
