

Sec. 2. The governor is hereby authorized and empowered to enter into and execute all deeds of conveyance and bills of sale necessary to carry out the purpose of this act. The form of deeds of conveyance and the bills of sale shall be approved by the attorney general.

#### CHAPTER 340—H. F. No. 1922

*An act relating to state fire marshal; amending Minnesota Statutes 1967, Section 73.59, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 73.59, Subdivision 1, is amended to read:

**73.59 State fire marshal; specifications and standards.** Subdivision 1. The fire marshal shall promulgate in the manner otherwise provided by law, reasonable rules and regulations necessary for or incident to the administration of sections 73.57 to 73.61, which among other matters shall prescribe specifications making public buildings constructed or remodeled after final enactment of sections 73.57 to 73.61 accessible to and usable by physically handicapped persons. ~~In prescribing the specifications the fire marshal shall set minimum specifications as set forth in the booklet entitled, "American Standard Specifications For Making Buildings And Facilities Accessible To And Usable By The Physically Handicapped," approved by the American Standard Association Incorporated, on October 31, 1961.~~

#### CHAPTER 341—H. F. No. 2027

*An act authorizing the issuance of bonds by Independent School District No. 112.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Independent school district No. 112; building bonds.** Notwithstanding the limitations of Minnesota Statutes, Section 475.53, Independent School District No. 112, by resolutions of its school board, is authorized to sell and issue the unissued balance of \$1,363,000 of bonds authorized to be issued by the voters at an election held December 12, 1968 for acquisition and betterment of school facilities. Such bonds may be sold and issued in such amounts and at such times as may be determined by the school board, in the manner prescribed by Minnesota Statutes, Chapter 475; provided, that if, prior to issuing any such bonds, the district obtains any capital loan or loans under Minnesota Statutes, Section 124.43, the amount of bonds hereby authorized to be issued shall be reduced by the amount of such loan or loans.

Sec. 2. This act applies only to Independent School District No. 112 which includes territory within the city of Chaska.

Sec. 3. This act takes effect when approved by the school board of Independent School District No. 112, and upon compliance with Minnesota Statutes, Section 645.021.

#### CHAPTER 342—H. F. No. 2068

[Coded]

*An act relating to reversion of trunk highways; providing for reversion to counties of trunk highways which border counties.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[161.161] Trunk highways; county line roads; reversion.** Where a trunk highway which is being reverted to a lower governmental subdivision is on or forms the line between two or more counties, the trunk highway shall revert to and remain the responsibility of the affected counties.
