amount and in excess of existing limitations and the monies collected on such tax levies shall be used only for the payment of the bonds authorized herein. The amount of such levy shall be subject to the supervision of any fiscal control agency which is now or hereafter provided in the charter of any such city. The levy shall be certified to the county auditor on or before October 10 of each year.

- Sec. 6. Full faith and credit pledged; charter limitation. The bonds hereby authorized or any part thereof shall be issued and sold pursuant to the provisions of Minnesota Statutes, Chapter 475, except that the bonds authorized herein may be issued without first obtaining the approval or a vote of the electors and the full faith and credit of such city at all times shall be pledged for the payment of any such bonds issued under this act and for the payment of the principal and interest thereon. Prior to the sale of the bonds, the governing body of the board of park commissioners of the city of Minneapolis shall by resolution determine that an epidemic or natural catastrophe emergency exists and that the amount to be raised by the bond sale is required by reason of the natural catastrophe or the disease epidemic.
- Sec. 7. Effective date of act. This act shall become effective upon approval by a majority of the governing body of the board of park commissioners of the city of Minneapolis, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
- Sec. 8. Minnesota Statutes 1967, Section 448.56, Subdivisions 3, 4 and 5; and Laws 1945, Chapter 210, as amended by Laws 1947, Chapter 333, and Laws 1967, Chapter 540, are repealed.

### CHAPTER 594—S. F. No. 1721-

#### [Not Coded]

An act relating to the firemen's relief association in the city of Fridley.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Fridley, city of; firemen's relief. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provde that the service pension

payable to a retired full time fireman, after age 55 years or more, pursuant to Minnesota Statutes, Sections 424.21 and 424.22, shall equal not more than 50 percent of the average salary of a first class fire fighter as measured by the previous five calendar years.

- Sec. 2. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the pension payable pursuant to Minnesota Statutes, Section 424.24, to the widow of a full time fireman who dies prior to his retirement shall equal not more than 25 percent of the average annual salary of the deceased fireman during the term of his full time employment.
- Sec. 3. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the pension payable pursuant to Minnesota Statutes, Section 424.24, to the widow of a full time fireman who dies after his retirement shall equal not more than 50 percent of the pension received by the deceased fireman prior to his death.
- Sec. 4. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that pensions payable pursuant to Minnesota Statutes, Section 424.24, to each surviving child of a deceased full time fireman shall equal not more than eight percent of the average annual salary of the deceased fireman during the term of his employment as a full time fireman.
- Sec. 5. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that if a full time fireman is permanently disabled from performing the duties of his position the disability benefit payable to him pursuant to Minnesota Statutes, Sections 424.19 and 424.20, shall equal not more than 45 percent of his average annual salary during the term of his employment as a full time fireman, where such disability is causally related to his employment as a fireman. Where such disability is not causally related to his employment as a fireman, and where he has at least ten years of service, the disability benefit shall equal not more than 22-1/2 percent of his average annual salary during the term of his employment as a full time fireman together with an additional 2-1/4 percent for each year of service beyond ten years, but not to exceed a total of 45 percent.
- Sec. 6. The bylaws of the firemen's relief association in the city of Fridley may provide that each year of service as a volunteer fireman in the fire department of the city of Fridley shall be deemed the equivalent of one half year of full time service for the purpose of

determining the period of full time service of any person who subsequently serves as a full time fireman in connection with the payment of pensions or other benefits to or in respect of such person under Minnesota Statutes, Chapter 424, or this act. The period of service as a volunteer fireman shall not be considered in determining average annual salary received during the term of full time employment.

- Sec. 7. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the service pension payable to a retired volunteer fireman age 55 years or more pursuant to Minnesota Statutes, Sections 424.21 and 424.22, shall be in the amount of \$100 per month, plus an additional \$3 per month for each year of service in excess of 20 years, and subject to a maximum pension of \$130 per month.
- Sec. 8. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the pension payable pursuant to Minnesota Statutes, Section 424.24, to the widow of a volunteer firman who dies prior to his retirement shall be not less than \$45 nor more than \$54 per month.
- Sec. 9. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the pension payable pursuant to Minnesota Statutes, Section 424.24, to the widow of a volunteer fireman who dies after his retirement shall be not less than \$45 nor more than \$54 per month.
- Sec. 10. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that the pension payable pursuant to Minnesota Statutes, Section 424.24, to each surviving child of a deceased volunteer fireman shall be \$18 per month.
- Sec. 11. Notwithstanding any provision of law to the contrary, the bylaws of the firemen's relief association in the city of Fridley may provide that if a volunteer fireman is permanently disabled from performing duties of his position the disability benefit payable to him pursuant to Minnesota Statutes, Sections 424.19 and 424.20, shall be in the amount of \$100 per month, where such disability is causally related to his employment as a fireman. Where such disability is not causally related to his employment as a fireman, and where he has at least ten years of service, the disability benefit shall be \$45 per month, plus \$5.50 per month for each year of service in excess of 10, and subject to a maximum of \$100 per month.
- Sec. 12. Subdivision 1. The treasurer of the city of Fridley and the secretary of the firemen's relief association in the city of Frid-

ley, maintaining and administering the firemen's pension fund, shall during the month of June of each year, prepare and certify an estimate of the necessary appropriation which will be sufficient to meet the current normal cost determined by the entry age normal cost method based upon a three percent interest assumption, plus an additional amount sufficient to retire the present accumulated deficit, if any, within 20 years after passage of this act. During the first year after passage of this act, and at least once every four years thereafter, the firemen's relief association shall obtain an actuarial survey and report to assist in the preparation of annual estimates required by this section, which survey and report shall be prepared in accordance with the provisions of Laws 1965, Chapter 751, as amended.

The records of account shall be maintained under the direction of the treasurer of the city of Fridley and the secretary of the firemen's relief association. The system of accounting employed shall be in accordance with generally accepted accounting principles, and shall employ applicable actuarial assumptions in a manner which will provide an actuarial measurement of the liabilities for accumulated pension reserves needed for in-service members, the liabilities for rights which have become vested, and the overall financial solvency of the fund. Within 90 days following the end of each fiscal year the treasurer of the city of Fridley shall submit a report to the city council which shall reflect the financial condition of the relief association fund.

- Subd. 2. The city shall levy a tax for the firemen's pension fund equal to the net amount so certified, in the manner and at the time it levies other taxes. When the fund has reached a point sufficient to fully fund the Fridley firemen's relief association, the tax levy shall be established at an amount sufficient to maintain the fund in a completely funded status as new obligations are incurred. The proceeds of this tax shall be paid into the firemen's pension fund.
- Subd. 3. The contribution of a full time fireman with respect to the pension program herein provided for shall be in an amount equal to six percent of the established salary of a first class fire fighter. Any such fireman who separates from service before becoming eligible for a benefit shall be entitled to a refund of his entire contributions.
- Sec. 13. Moneys in the pension fund shall be disbursed only for purposes and in the manner authorized by the articles of incorporation or bylaws of the association. Before any moneys in the fund are invested in order to earn income or any change in the bylaws relative to the purpose or manner of disbursement is made, the association

shall obtain the approval of the city council of Fridley. All moneys credited to the firemen's pension fund which are not required for current expenses shall be invested in accordance with standards and limitations applicable to investments of the state employees retirement fund as established by statute.

- Sec. 14. The bylaws of the firemen's relief association of the city of Fridley referred to in this act shall not be effective unless approved by the governing body of the city of Fridley.
- Sec. 15. No provision of this act shall be construed as reducing the amount or rate of contribution to the association by the municipality or a member of the association from such minimum contributions as are prescribed by the Police and Firemen's Relief Associations Guidelines Act of 1969.
- Sec. 16. This act shall be in effect upon its approval by the governing body of the city of Fridley and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

### CHAPTER 595—S. F. No. 1745

An act relating to corrections; providing for an Interstate Corrections Compact for the reciprocal confinement of persons convicted of felony.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. [241.28] Interstate corrections compact. This chapter may be cited as the Interstate Corrections Compact.
- Sec. 2. [241.29] Compact. The Interstate Corrections Compact is hereby enacted into law and entered into by this state with any other states legally joining therein in the form substantially as follows:
