Subd. 1a. Parking facilities. The state college board may establish rents, charges or fees in an amount not to exceed \$1 per vehicle per day for the use of parking facilities owned, leased, occupied, or operated by the state college board. The money collected by the board as rents, charges or fees in accordance with this subdivision shall be deposited in the college activity fund and is annually appropriated to the state college board for state college purposes and to maintain and operate parking lots and parking facilities.

CHAPTER 702-H. F. No. 794

An act relating to state parks, recreation reserves, and waysides; providing employee motor vehicle permits for driving motor vehicles therein; amending Minnesota Statutes 1967, Section 85.05, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1967, Section 85.05, Subdivision 2, is amended to read:
- Subd. 2. State parks; permits for motor vehicles. Except as provided in clause (b) of this subdivision, no motor vehicle shall enter or be permitted to enter any state park, memorial state park, state recreational reserve or wayside over 50 acres in area unless it has affixed to its windshield in the lower right corner thereof a permit which is provided for hereinafter. The commissioner of conservation shall procure permits in such form as he shall prescribe for each calendar year which by appropriate language shall grant permission to use any state park, memorial state park, state recreational reserve or wayside over 50 acres in area. Permits for each calendar year shall be provided and placed on sale before October 1 next preceding, and may be affixed and used on or at any time after said date until the end of the calendar year for which issued. Such permits in each category shall be numbered consecutively for each year of issue. A fee of \$2 shall be charged for each permit issued, except that permits of appropriate special design may be sold individually at 50 cents covering the use of state parks, memorial state parks, state recreational reserves or waysides under such

conditions as the commissioner may prescribe for a designated period of not more than two days. The fee collected shall be deposited in the state park development account in the state treasury. Such permits shall be issued by such employees of the division of parks and recreation as the commissioner of conservation may designate in writing and as hereinbefore provided. (b) The commissioner shall issue without charge an employee's motor vehicle permit to any state employee who, for the purpose of performing official duties, must enter places where park stickers are required. The employee shall display his employee's permit on his motor vehicle in the same manner as state park stickers are displayed. A motor vehicle displaying only an employee's permit may not enter a place where park stickers are required if the vehicle is used for purposes other than those authorized by this clause (b).

Sec. 2. Effective date. This act is effective 30 days after final enactment.

CHAPTER 703-H. F. No. 903

An act relating to welfare; authorizing the commissioner to conduct experimental public assistance projects; amending Minnesota Statutes 1967, Section 256.01, Subdivision 2.

- Section 1. Minnesota Statutes 1967, Section 256.01, Subdivision 2, is amended to read:
- Subd. 2. Public welfare; experimental public assistance projects; specific powers. The commissioner of public welfare shall:
- (1) Administer and supervise all forms of public assistance in the state including general relief, relief to transients and state homeless, old age assistance, aid to dependent children, aid to the blind and otherwise handicapped persons and such other welfare activities or services as may from time to time be vested in the commissioner. Nothing herein shall transfer from the veterans home board any of its present rights, powers, or duties, all of which shall continue to be exercised by said board.
- (2) Administer and supervise all child welfare activities; promote the enforcement of laws protecting defective, illegitimate, de-
