

CHAPTER 783—H. F. No. 2156

An act relating to the city of St. Paul; authorizing an additional license for the sale of intoxicating liquor at the civic center.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Paul, city of; civic center liquor license.** Subdivision 1. In addition to the licenses now authorized by law, and notwithstanding any provision of law to the contrary contained in the charter or ordinances of such city, or statutes applicable to such city, the city of St. Paul is authorized to issue an "on sale" liquor license for the premises known and used as the St. Paul civic center. The license so authorized shall be issued only to the person, firm or corporation holding a contract to provide food catering service at said civic center and shall terminate whenever the contract for food catering service is terminated. The fee for such license shall be fixed by the governing body of the city of St. Paul. Such liquor license shall be issued in accordance with the statutes applicable to the issuance of "on sale" liquor licenses in cities of the first class not inconsistent herewith and in accordance with the charter and ordinances of the city of St. Paul not inconsistent herewith and shall limit the sale of intoxicating liquor to members and guests of any person or organization leasing space in the civic center for the purpose of conducting any convention, banquet, conference, meeting or social affair, and shall prohibit the sale of intoxicating liquor to the public or to any persons attending or participating in any athletic event being held on the civic center premises.

Subd. 2. The power conferred by this act shall be a continuing power, and shall be in addition to all other powers possessed by the city of St. Paul.

CHAPTER 784—H. F. No. 2211

An act relating to Lake county; authorizing county to appropriate money under certain conditions to a hospital and nursing home.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Lake county; hospital and nursing home.** Notwithstanding Minnesota Statutes, Section 376.08, and in lieu thereof, Lake county shall, upon compliance with the requirements of this act, aid Lake View Memorial Hospital and nursing home located in the city of Two Harbors, county of Lake, by appropriating from its general revenue fund for the hospital and nursing home, the amount of \$35,000 annually for a ten year period commencing December 1, 1970.

Sec. 2. The county board of Lake county shall submit to the voters of Lake county at the general election held in November, 1970, the following question:

"Shall the county board give aid to Lake View Memorial Hospital and nursing home, by making an annual contribution of \$35,000 to Lake View Memorial Hospital, Inc., for a period of ten years commencing December 1, 1970?"

Sec. 3. If a majority of the voters voting on the question vote in favor of the question, the county board of Lake county shall appropriate from the general revenue fund and pay annually for a ten year period the amount of \$35,000 to Lake View Memorial Hospital, Inc., commencing December 1, 1970, or as soon thereafter as practical.

Sec. 4. It shall be the duty of the county board to levy each year sufficient ad valorem taxes upon all the taxable property in the county to enable it to have sufficient moneys in the general revenue fund to make the payments specified in section 3 of this act.

Sec. 5. Any amounts paid by the county to said Lake View Memorial Hospital, Inc., prior to the effective date of this act pursuant to Minnesota Statutes, Section 376.08, shall be credited to the county with respect to its first annual payment to the hospital organization.

Sec. 6. If a majority of the voters voting on the question vote against the question, the county board of Lake county may aid the hospital or nursing home pursuant to Minnesota Statutes, Section 376.08, or any other applicable sections of the law.

Sec. 7. This act takes effect upon approval by the board of county commissioners of Lake county, and upon compliance with Minnesota Statutes, Section 645.021.
