Sec. 14. Study. The workmen's compensation advisory committee shall study and present to the legislature and the governor prior to January 1, 1971, its findings relative to the cost, method of financing, and the formula to be used to provide supplemental benefits to those workers who have been determined to be permanently and totally disabled prior to July 1, 1969.

Sec. 15. Effective date. This act is effective September 1, 1969.

CHAPTER 937—S.F. No. 2002

An act providing for certain positions to be in the unclassified service of the city of Minneapolis.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minneapolis, city of; unclassified service. Subdivision 1. Notwithstanding any provisions of the Minneapolis city charter, veterans preference act, or civil service rule, law, or regulation to the contrary, the positions referred to in subdivisions 2, 3 and 4 of this section shall be in the unclassified service of the city of Minneapolis, and any person presently holding or who shall hereafter be appointed to any of such positions shall serve at the pleasure of the appointing authority indicated in the respective subdivision.

Subd. 2. The city council by a majority vote thereof may appoint not more than three suitable persons as it may deem necessary to serve as administrative aides to the council and its presiding officer and may designate such positions by such titles as it shall determine.

Subd. 3. The mayor of the city of Minneapolis may appoint a suitable person as his administrative deputy.

Subd. 4. Such appointing authority as may be designated by ordinance of the city of Minneapolis may appoint any suitable person as director of the department of human rights of said city.

Sec. 2. If a person appointed to any of the positions referred to in section 1 of this act is at the time of such appointment a member of the classified service of the city of Minneapolis, such appointee shall be deemed to be on leave of absence during his tenure in such

appointive position, and upon the termination of such service shall be returned to his permanent civil service classification. If no vacancy is available in his permanent civil service classified position, seniority shall prevail and the person most recently certified to such position shall be returned to the permanent civil service classification held by him prior to such certification.

Sec. 3. This act shall become effective only after its approval by a majority of the governing body of the city of Minneapolis and upon compliance with the provisions of Minnesota Statutes 1967, Section 645.021.

CHAPTER 938-H. F. No. 68

An act relating to business corporations; authorizing formation of regional tourism development credit corporations; amending Minnesota Statutes 1967, Chapter 301, by adding sections.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Chapter 301, is amended by adding a section to read:

[301.85] Regional tourism development credit corporations. Subdivision 1. For the purposes of sections 301.85 to 301.98, the commissioner of the department of economic development of the state shall divide the state into six tourist regions and shall keep on file in his office and in the office of the secretary of state the legal descriptions and a map of such regions.

Subd. 2. Any ten or more natural persons who are residents of the state and residents of the same region may form a regional tourism development credit corporation to serve the region in which they are residents by complying with the conditions prescribed in sections 301.85 to 301.98.

Subd. 3. They subscribe and acknowledge a certificate specifying:

(a) The name, the general nature of its business, and the principal place of transacting its business, which place shall be located in the region the corporation is formed to serve. The name shall distinguish the corporation from all other corporations authorized to do
