the proceeds of sales attributed by the taxpayer to the business conducted at such place outside the state.

CHAPTER 979—H. F. No. 2443

An act relating to Afton state park; authorizing the acquisition of lands therefor; appropriating money.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [85.1873] State parks; Afton state park. Subdivision 1. Afton state park is established in Washington county.

Subd. 2. The commissioner of administration for the commissioner of conservation is authorized to acquire by gift or purchase the following described land in Washington county:

In Township 28 North, Range 20 West. All that part of the Southeast Quarter of the Southeast Quarter of Section 33 lying easterly of C.S.A.H. 21.

All of the Southeast Quarter and the East Half of the Southwest Quarter; all of the West Half of the Southwest Quarter except the north 1522 feet of the west 660 feet; all in Section 34.

All of Government Lots 2, 3, and 4, the Northwest Quarter of the Southwest Quarter and the Southwest Quarter of the Northwest Quarter; all in Section 35.

In Township 27 North, Range 20 West. All of Government Lots 5 and 8 and the Southwest Quarter of the Southwest Quarter; all that part of Government Lot 7 lying easterly of the Township road; all of Government Lot 6 except that part described as follows: commencing at the northwest corner of Section 2, thence S. 01° 09′ W., 1144 ft. along the West line to the northwest corner of Government Lot 6, thence easterly 1174 feet along the North line of Government Lot 6, thence S. 18° 15′ W., 377.8 ft., thence S. 42° 58′ W., 232.4 ft. to the point of beginning, thence S. 53° 53′ W., 130 ft., thence S. 28° 50′ W., 347.5 ft., thence S. 13° 50′ W., 369.7 ft. along the traveled road to the South line of Government Lot 6, thence westerly

along the said South line to the southwest corner of Government Lot 6, thence northerly along the West line to a point 300 ft. south of the Northwest corner of Government Lot 6, thence southeasterly to the point of beginning; all in Section 2.

All of the North Half of the Northeast Quarter, the Northeast Quarter of the Northwest Quarter, all that part of the Northwest Quarter of the Northwest Quarter lying easterly of C.S.A.H. 21; all that part of the Southeast Quarter of the Northwest Quarter described as follows: beginning at the Northeast corner of said Southeast Quarter of the Northwest Quarter, then South 460 ft. along the East line of the Southeast Quarter of the Northwest Quarter, thence Southwesterly 493.9 ft. to a point 193.4 ft. West of the said East line, thence Northwesterly to a point on the North line of the said Southeast Ouarter of the Northwest Ouarter 756 ft. West of the point of beginning, thence East 756 ft. along said North line to said point of beginning, together with a scenic easement on a strip of land 150 feet wide adjacent to and parallel with the Southwest border of the above described tract; all of the South half of the Southwest Ouarter except the North 800 ft. thereof and except that part thereof lying West of C.S.A.H. 21; all of the Southwest Quarter of the Southeast Quarter except the north 800 ft.; all of the Southeast Quarter of the Southeast Quarter except: beginning at the Northwest corner thereof, thence south 900 ft. along the West line thereof, thence east 660 ft. parallel with the North line thereof, thence northeasterly to a point on the township road 275 ft. south of the North line thereof, thence northerly along the said township road to the said North line, thence west along the said North line to the Northwest corner thereof and the point of beginning; all in Section 3.

All that part of the Northeast Quarter of the Northeast Quarter of Section 4 lying easterly of C.S.A.H. 21.

The North Half of the Northeast Quarter and all that part of the North Half of the Northwest Quarter lying easterly of C.S.A.H. 21; all in Section 10.

All of Government Lots 5 and 6, and the West Half of the Northwest Quarter; all in Section 11.

The lands so acquired shall be administered in the same manner as provided for other state parks and shall be perpetually dedicated for such use.
