relating to higher education; requiring submission of information to the legislature prior to the introduction of a bill appropriating money to the Board of Regents of the University Minnesota; requiring annual reporting; directing the commissioner of health to provide recommendations for a health professions workforce advisory council; appropriating money for the academic health system at the University of Minnesota; proposing coding for new law in Minnesota Statutes, chapter 137.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. [137.095] EVIDENCE IN SUPPORT OF APPROPRIATION.

- Subdivision 1. Written report. Prior to the introduction of a bill proposing to appropriate money to the Board of Regents of the University of Minnesota to benefit the University of Minnesota's health sciences programs, the proponents of the bill must submit a written report to the chairs and ranking minority members of the legislative committees with jurisdiction over higher education and health and human services policy and finance setting out the information required by this section. The University of Minnesota's health sciences programs include the schools of medicine, nursing, public health, pharmacy, dentistry, and veterinary medicine.
- 1.18 Subd. 2. Contents of report. The report required under this section must include the following information as specifically as possible:
- 1.20 (1) the dollar amount requested;
- 1.21 (2) how the requested dollar amount was calculated;
- 1.22 (3) the necessity for the appropriation's purpose to be funded by public funds;
- (4) a funds flow analysis supporting the necessity analysis required by clause (3);

6.1	Subd. 3. Workforce development. \$15,000,000 is appropriated in fiscal year 2025 from
6.2	the general fund to the Board of Regents of the University of Minnesota to expand education
6.3	and workforce development opportunities, including through the development of new career
6.4	pathways for health care professionals. This expansion should seek to train more health
6.5	care professionals, and to identify Minnesota-specific needs and targets. The University of
6.6	Minnesota's six academic health science programs should be utilized to provide unique

6.18	primary care. The transformation should improve access to primary care and specialists
6.19	around Minnesota, and increase support for physicians in rural and underserved communities.
6.20	Such access may be achieved through:
6.21	(1) increasing and improving electronic consultations between providers and patients;
6.22	(2) increasing and improving online medical consultations for primary care providers
6.23	to seek a specialist's opinion regarding a patient's diagnosis and treatment;
6.24	(3) building physician networks;
6.25	(4) promoting continuing medical education; and
6.26	(5) providing advanced telehealth.
6.27	Subd. 5. New care model design. \$5,000,000 is appropriated in fiscal year 2025 from
6.28	the general fund to the Board of Regents of the University of Minnesota to support the
6.29	Center for Learning Health Systems Sciences. Such support should be utilized to achieve
6.30	better outcomes, cost efficiencies, and the ability to share best practices in health care
6 31	delivery across health systems.

7.1 Subd. 6. All systems innovation. \$4,750,000 is appropriated in fiscal year 2025 from the general fund to the Board of Regents of the University of Minnesota to develop and 7.2 implement solutions to common health care challenges across health care systems that 7.3 include partnership with one or more health care systems. This may be achieved by: 7.4 7.5 (1) a prehospital care network; (2) a rural health clinical trials network; 7.6 7.7 (3) strategies to address clinician burnout; or (4) addressing other areas identified in consultation with the Minnesota Department of 7.8 Health. 7.9 Subd. 7. Public health care collaboration; report. (a) \$250,000 is appropriated in 7.10 fiscal year 2025 from the general fund to the Board of Regents of the University of Minnesota 7.11 to support an analysis of opportunities for partnership between the state's public health care 7.12 delivery entities: the University of Minnesota; Hennepin Health; and the Veterans Affairs 7.13 hospitals. The purpose of this work is to determine the feasibility of shared facilities, common 7.14 ancillary services, shared research infrastructure, clinical collaboration, and other 7.15 interventions that drive cost efficiencies and enhance access for Minnesotans. The state 7.16 requests that the University of Minnesota convene all three organizations to determine the 7.17 scope of the work, select a vendor for the analysis, and oversee the project. 7.18 (b) On or before December 31, 2024, the University of Minnesota must submit a report 7.19 to the chairs and ranking minority members of the legislative committees with jurisdiction 7.20 over health and human services finance and policy outlining the findings, the next steps, 7.21 and the resources necessary to achieve the goals set forth in the report. 7.22
