1.6	Section 1. Minnesota Statutes 2018, section 116J.8748, subdivision 3, is amended to read:
1.7	Subd. 3. Minnesota job creation fund business designation; requirements. (a) To
1.8	receive designation as a Minnesota job creation fund business, a business must satisfy all
1.9	of the following conditions:
