1.11	Subd. 2. Appointing authority; powers and duties. Election judges for precincts in a
1.12	municipality shall be appointed by the governing body of the municipality. Election judges
1.13	for precincts in unorganized territory and for performing election-related duties assigned
1.14	by the county auditor shall be appointed by the county board. Election judges for a precinct
1.15	composed of two or more municipalities must be appointed by the governing body of the
1.16	municipality or municipalities responsible for appointing election judges as provided in the
1.17	agreement to combine for election purposes. Except as otherwise provided in this section,
