1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2022, section 268.19, subdivision 1, is amended to read:
1.6	Subdivision 1. Use of data. (a) Except as provided by this section, data gathered from
1.7	any person under the administration of the Minnesota Unemployment Insurance Law are
1.8	private data on individuals or nonpublic data not on individuals as defined in section 13.02,
1.9	subdivisions 9 and 12, and may not be disclosed except according to a district court order
1.10	or section 13.05. A subpoena is not considered a district court order. These data may be
1.11	disseminated to and used by the following agencies without the consent of the subject of
1.12	the data:
1.13	(1) state and federal agencies specifically authorized access to the data by state or federal
1.14	law;
1.15	(2) any agency of any other state or any federal agency charged with the administration

3.13	and 13, and must not be disclosed except under statute or district court order or to a party
3.14	named in a criminal proceeding, administrative or judicial, for preparation of a defense.
3.15	(c) Data gathered by the department in the administration of the Minnesota unemployment
3.16	insurance program must not be made the subject or the basis for any suit in any civil

3.17 proceedings, administrative or judicial, unless the action is initiated by the department.
