1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2022, section 135A.17, subdivision 2, is amended to read:
1.8	Subd. 2. Residential housing list. All postsecondary institutions that enroll students
1.9	accepting state or federal financial aid may prepare a current list of students enrolled in the
1.10	institution and residing in the institution's housing or within ten miles of the institution's
1.11	campus. All postsecondary institutions that enroll students accepting state financial aid
1.12	must, to the extent the information may be disclosed pursuant to Code of Federal Regulations,
1.13	title 34, part 99, prepare a current list of students enrolled in the institution and residing in
1.14	the institution's housing or within ten miles of the institution's campus. The list shall include
1.15	each student's current address, unless the student is enrolled in the Safe at Home address
1.16	confidentiality program as provided in chapter 5B. The list shall be certified and sent to the
1.17	appropriate county auditor or auditors for use in election day registration as provided under
1.18	section 201.061, subdivision 3. A residential housing list provided under this subdivision
1.19	may not be used or disseminated by a county auditor or the secretary of state for any other
1.20	purpose.

2.3	Subd. 3a. Additional proofs of residence permitted for students. (a) An eligible voter
2.4	may prove residence by presenting a current valid photo identification issued by a
2.5	postsecondary educational institution in Minnesota if the voter's name; student identification
2.6	number, if available; and address within the precinct appear on a current residential housing
2.7	list under section 135A.17, certified to the county auditor by the postsecondary educational
2.8	institution.
2.9	(b) This additional proof of residence for students must not be allowed unless the
2.10	postsecondary educational institution submits to the county auditor no later than 60 days
2.11	prior to the election a written agreement that the postsecondary educational institution will
2.12	certify for use at the election accurate updated residential housing lists under section 135A.17.
2.13	A written agreement is effective for the election and all subsequent elections held in that
2.14	calendar year, including the November general election.
2.15	(c) The additional proof of residence for students must be allowed on an equal basis for
2.16	voters who reside in housing meeting the requirements of section 135A.17, if the residential
2.17	housing lists certified by the postsecondary educational institution meet the requirements
2.18	of this subdivision.
2.19	(d) An updated residential housing list must be certified to the county auditor no earlier
2.20	than 20 days prior to each election. The certification must be dated and signed by the chief
2.21	officer or designee of the postsecondary educational institution and must state that the list
2.22	is current and accurate and includes only the names of persons residing as of the date of the
2.23	certification.
2.24	(e) The county auditor shall instruct the election judges of the precinct in procedures for
2.25	use of the list in conjunction with photo identification. The auditor shall supply a list to the
2.26	election judges with the election supplies for the precinct.
2.27	(f) The county auditor shall notify all postsecondary educational institutions in the county
2.28	of the provisions of this subdivision.

2.30	Subdivision 1. Forms. (a) All postsecondary institutions that enroll students accepting
2.31	state or federal financial aid shall must provide voter registration forms to each student as
2.32	early as possible in the fall quarter during the fall and spring of each year. In state election
2.33	years, it must be provided 15 days in advance of the deadline for registering to vote for the

3.1 state general election. If the voter registration forms are provided electronically, the electronic
3.2 message must be devoted exclusively to voter registration.

3.3 (b) All school districts shall must make available voter registration applications each 3.4 May and September to all students registered as students of the school district who will be 3.5 eligible to vote at the next election after those months. A school district has no obligation 3.6 to provide voter registration applications to students who participate in a postsecondary 3.7 education option program or who otherwise reside in the district but do not attend a school 3.8 operated by the district. A school district fulfills its obligation to a student under this section 3.9 if it provides a voter registration application to the student one time.

3.10 (c) The <u>voter registration</u> forms must contain spaces for the information required in 3.11 section 201.071, subdivision 1, and applicable rules of the secretary of state. The institutions 3.12 and school districts may request these forms from the secretary of state. Institutions shall 3.13 <u>must</u> consult with their campus student government in determining the most effective means 3.14 of distributing the forms and in seeking to facilitate election day registration of students 3.15 under section 201.061, subdivision 3. School districts must advise students that completion 3.16 of the voter registration application is not a school district requirement.

3.17 (d) The institutions and school districts must report to the secretary of state by November

3.18 <u>30 of each year on their implementation of this section. At a minimum, the report must</u>

3.19 include how and when the forms were distributed, how many were distributed, and how

3.20 many were completed. Institutions and school districts may include information about

3.21 methods that were effective in increasing student registrations.

- 3.22 (e) By February 1 of each year, the secretary of state must report to the chairs and ranking
 3.23 minority members of the legislative committees with jurisdiction over elections on the data
 3.24 received from institutions and school districts. The secretary must highlight best practices
 3.25 and innovative methods that were most effective in registering students to vote.
