1.9	degradation, and to protect drinking water sources by:			
1.10	(1) providing grants, loans, and technical assistance to public agencies and others			
1.11	testing waters, identifying impaired waters, developing total maximum daily loads,			
1.12	implementing restoration plans for impaired waters, and evaluating the effectiveness			
1.13	of restoration;			
1.14	(2) supporting measures to prevent surface waters from becoming impaired and to			
1.15	improve the quality of waters that are listed as impaired, but do not have an approved total
