1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2022, section 168.33, subdivision 7, is amended to read:
1.6	Subd. 7. Filing fees; allocations. (a) In addition to all other statutory fees and taxes, a
1.7	filing fee of:
1.8	(1) $\frac{1}{57}$ is imposed on every vehicle registration renewal, excluding pro rate
1.9	transactions; and
1.10	(2) $\frac{11}{17}$ is imposed on every other type of vehicle transaction, including motor carrier
1.11	fuel licenses under sections 168D.05 and 168D.06, and pro rate transactions.
1.12	(b) Notwithstanding paragraph (a):
1.13	(1) a filing fee may not be charged for a document returned for a refund or for a correction
1.14	of an error made by the Department of Public Safety, a dealer, or a deputy registrar; and
1.15	(2) no filing fee or other fee may be charged for the permanent surrender of a title for a
1.16	vehicle.
1.17	(c) The filing fee must be shown as a separate item on all registration renewal notices
1.18	sent out by the commissioner.
1.19	(d) The statutory fees and taxes, and the filing fees imposed under paragraph (a) may
1.20	be paid by credit card or debit card. The deputy registrar may collect a surcharge on the
1.21	statutory fees, taxes, and filing fee not greater than the cost of processing a credit card or

2.20	(b) The statutory fees and the filing fees imposed under paragraph (a) may be paid by
2.21	credit card or debit card. The driver's license agent may collect a convenience fee on the

2.23	card transaction. The convenience fee must be used to pay the cost of processing credit card
