1.5	Section 1. [3.8865] LEGISLATIVE WATER COMMISSION.
1.6	Subdivision 1. Establishment. The Legislative Water Commission is established.
1.7	Subd. 2. Membership. (a) The Legislative Water Commission consists of 12 members
1.8	appointed as follows:
1.9	(1) six members of the senate, including three majority party members appointed by the
1.10	majority leader and three minority party members appointed by the minority leader; and
1.11	(2) six members of the house of representatives, including three majority party members
1.12	appointed by the speaker of the house and three minority party members appointed by the
1.13	minority leader.
1.14	(b) Members serve at the pleasure of the appointing authority and continue to serve until
1.15	their successors are appointed or until a member is no longer a member of the legislative
1.16	body that appointed the member to the commission. Vacancies must be filled in the same
1.17	manner as the original positions. Vacancies occurring on the commission do not affect the
1.18	authority of the remaining members of the Legislative Water Commission to carry out the
1.19	functions of the commission.
1.20	(c) Members must elect a chair, vice-chair, and other officers as determined by the
1.21	commission. The chair may convene meetings as necessary to perform the duties prescribed

2.1	Subd. 3. Commission staffing. The Legislative Coordinating Commission must employ
2.2	staff and contract with consultants as necessary to enable the Legislative Water Commission
2.3	to carry out its duties and functions.
2.4	Subd. 4. Powers and duties. (a) The Legislative Water Commission must review water
2.5	policy reports and recommendations of the Environmental Quality Board, the Board of
2.6	Water and Soil Resources, the Pollution Control Agency, the Department of Natural
2.7	Resources, and the Metropolitan Council and other water-related reports as may be required
2.8	by law or the legislature.
2.9	(b) The commission may conduct public hearings and otherwise secure data and
