1.2 relating to transportation; amending various provisions related to transportation
1.3 policy, including logo sign program, trunk highway routes, state-aid systems,
1.4 motor vehicle registration, license plates, vehicle dealers, pupil transportation,
1.5 traffic regulations, bicycles, parking, motor vehicle equipment, driver licensing,

1.23 Section 1. Minnesota Statutes 2012, section 160.80, subdivision 1, is amended to read:

1.24 Subdivision 1. **Commissioner may establish program.** (a) The commissioner of
1.25 transportation may establish a sign franchise program for the purpose of providing on the
1.26 right-of-way of interstate and controlled-access trunk highways specific information on
1.27 gas, food, camping, lodging, attractions, and 24-hour pharmacies for the benefit of the
1.28 motoring public.

1.29 (b) The sign franchise program must include urban interstate highways.

1.30 Sec. 2. Minnesota Statutes 2012, section 160.80, subdivision 1a, is amended to read:

2.1 Subd. 1a. **Eligibility criteria for business panels.** (a) To be eligible for a business
2.2 panel on a logo sign panel, a business establishment must:

2.3 (1) be open for business;

2.4 (2) have a sign on site that both identifies the business and is visible to motorists;

2.5 (3) be open to everyone, regardless of race, religion, color, age, sex, national origin,
2.6 creed, marital status, sexual orientation, or disability; and

2.7 (4) ~~not impose a cover charge or otherwise require customers to purchase additional~~
2.8 ~~products or services; and~~

2.9 (5) meet the appropriate criteria in paragraphs (b) to (f) (k).

2.10 (b) Gas businesses must provide vehicle services including fuel gas or alternative
2.11 fuels and oil; restroom facilities and drinking water; continuous, staffed operation at least

2.13 (c) Food businesses must serve at least two meals a day during normal mealtimes
2.14 of breakfast, lunch, and dinner; provide a continuous, staffed food service operation at

2.16 645.44, subdivision 5, and except as provided for seasonal food service businesses;
2.17 provide seating capacity for at least 20 people; provide restroom facilities; provide public
2.18 access to a telephone; and possess any required state or local licensing or approval.

2.19 Seasonal food service businesses must provide a continuous, staffed food service operation

2.23 access to a telephone, provide restroom facilities, and possess any required state or local

2.25 (e) Camping businesses must include sites for camping, include parking
2.26 accommodations for each campsite, provide sanitary facilities and drinking water, and
2.27 possess any required state or local licensing or approval.

2.28 (f) 24-hour pharmacy businesses must be continuously operated 24 hours per day,
2.29 seven days per week, and must have a state-licensed pharmacist present and on duty at
2.30 all times.

2.31 (g) Attractions businesses must have regional significance with the primary purpose
2.32 of providing amusement, historical, cultural, or leisure activities to the public; provide
2.33 restroom facilities and drinking water; possess any required state or local licensing
2.34 approval; and provide adequate bus and vehicle parking accommodations for normal
2.35 attendance.

 3.2 by either putting the full months of operation directly on the business panel or by having a
 3.3 "closed" plaque applied to the business panel when the business is closed for the season.

3.4 ~~(h)~~ (i) The maximum distance that an eligible business in ~~Anoka, Carver, Dakota,~~
 3.5 ~~Hennepin, Ramsey, Scott, or Washington County~~ an urban area can be located from the
 3.6 interchange is: for gas, food, lodging, attraction, and 24-hour pharmacy businesses, ~~one~~
 3.7 ~~mile~~ three miles; for ~~food businesses, two miles; for lodging businesses and 24-hour~~
 3.8 ~~pharmacies, three miles; and for camping businesses, ten miles.~~

3.9 ~~(i)~~ (j) The maximum distance that an eligible business in ~~any other county~~ a rural
 3.10 area can be located from the interchange shall not exceed 15 miles in either direction,
 3.11 except the maximum distance that an eligible 24-hour pharmacy business can be located
 3.12 from the interchange shall not exceed three miles in either direction.

3.13 ~~(j)~~ Logo sign panels must be erected so that motorists approaching an interchange

3.15 ~~(k)~~ If there is insufficient space on a logo sign panel to display all eligible businesses
 3.16 for a specific type of service, the businesses closest to the interchange have priority over
 3.17 businesses farther away from the interchange.

3.18 (k) If there is available space on a logo sign panel and no application has been
 3.19 received by the franchise from a fully eligible business, a substantially eligible business
 3.20 may be allowed the space.

3.22 Subd. 2. **Franchises.** The commissioner may, by public negotiation or bid, grant
 3.23 one or more franchises to qualified persons to erect and maintain, on the right-of-way of
 3.24 interstate and controlled-access trunk highways, signs informing the motoring public of
 3.25 gas, food, lodging, camping facilities, attractions, and 24-hour pharmacies. A franchisee
 3.26 shall furnish, install, maintain, and replace signs for the benefit of advertisers who provide

8.12 above the second letter and both letters just preceding the first numeral of the special

8.14 (c) For a veteran who served during World War I or World War II, the plates must
8.15 bear the inscription "WORLD WAR VET." and:

8.16 (1) for a World War I veteran, the characters "W" and "I" with the first character
8.17 directly above the second character and both characters just preceding the first numeral
8.18 of the special plate number; or

8.19 (2) for a World War II veteran, the characters "W" and "I" with the first character
8.20 directly above the second character and both characters just preceding the first numeral of
8.21 the special plate number.

8.22 (d) For a veteran who served during the Korean Conflict, the special plates must
8.23 bear the inscription "KOREAN VET." and the letters "K" and "V" with the first letter
8.24 directly above the second letter and both letters just preceding the first numeral of the
8.25 special plate number.

8.26 (e) For a combat wounded veteran who is a recipient of the Purple Heart medal, the
8.27 plates must bear the inscription "COMBAT WOUNDED VET" and have a facsimile or an
8.28 emblem of the official Purple Heart medal and the letters "C" over "W" with the first letter
8.29 directly over the second letter just preceding the first numeral of the special plate number.

8.30 A member of the United States armed forces who is serving actively in the military
8.31 and who is a recipient of the Purple Heart medal is also eligible for this license plate.
8.32 The commissioner of public safety shall ensure that information regarding the required
8.33 proof of eligibility for any applicant under this paragraph who has not yet been issued
8.34 military discharge papers is distributed to the public officials responsible for administering

9.4 the purposes of this section, "Persian Gulf War veteran" means a person who served on
9.5 active duty after August 1, 1990, in a branch of the armed forces of the United States or
9.6 a nation or society allied with the United States or the United Nations during Operation
9.7 Desert Shield, Operation Desert Storm, or other military operation in the Persian Gulf
9.8 area combat zone as designated in United States Presidential Executive Order No. 12744,

9.10 (g) For a veteran who served in the Laos War after July 1, 1961, and before July 1,
9.11 1978, the special plates must bear the inscription "LAOS WAR VET." ~~and the letters "L"~~

9.13 ~~the first numeral of the special plate number.~~

9.14 (h) For a veteran who is the recipient of:

9.15 (1) the Iraq Campaign Medal, the special plates must be inscribed with a facsimile of
9.16 that medal and must bear the inscription "IRAQ WAR VET" directly below the special
9.17 plate number;

9.18 (2) the Afghanistan Campaign Medal, the special plates must be inscribed with a
9.19 facsimile of that medal and must bear the inscription "AFGHAN WAR VET" directly
9.20 below the special plate number;

9.21 (3) the Global War on Terrorism Expeditionary Medal, the special plates must
9.22 be inscribed with a facsimile of that medal and must bear the inscription "GWOT
9.23 VETERAN" directly below the special plate number; or

9.24 (4) the Armed Forces Expeditionary Medal, the special plates must bear an
9.25 appropriate inscription that includes a facsimile of that medal.

9.26 (i) For a veteran who is the recipient of the Global War on Terrorism Service Medal,

10.5 the inscription "SILVER STAR VET" and have a facsimile or an emblem of the official
10.6 Silver Star medal.

168.094 ONE-WAY TRIP PERMIT.

Subdivision 1. **Application, fee, requirements.** Whenever a person seeks to operate a motor vehicle or tow a manufactured home owned by a nonresident upon the highways of this state solely for the purpose of transporting it from a point outside the state to another point outside the state, and such vehicle is not otherwise exempt from registration and taxation as provided by law, such owner shall not be required to register the vehicle and pay the tax but in lieu thereof shall apply to the registrar for a one-way trip permit and pay a fee of \$10. Unless such act of transportation also requires approval by the commissioner of transportation as provided in section 169.86, such person may be permitted to proceed with such vehicle into the state, not to exceed 35 miles, to the nearest city wherein a deputy registrar is located before securing such permit. The application for permit shall be in such form and contain such information as the registrar may determine. Any motor vehicle operated under such permit shall carry no load. As used in this section, "person" includes a natural person, firm, copartnership, association, or corporation.

Subd. 2. **Proceeds to highway user fund.** Fees collected pursuant to subdivision 1 shall be paid into the state treasury and credited to the highway user tax distribution fund.

Subd. 5. **Method of payment, operating assistance.** Payments for operating assistance under this section from state sources of funds must be made in the following manner:

(a) For payments made from the general fund:

- (1) 50 percent of the total contract amount in or before the first month of operation;
- (2) 40 percent of the total contract amount in or before the seventh month of operation;
- (3) 9 percent of the total contract amount in or before the 12th month of operation; and
- (4) 1 percent of the total contract amount after the final audit.

(b) For payments made from the greater Minnesota transit account:

- (1) 50 percent of the total contract amount in or before the seventh month of operation; and
- (2) 50 percent of the total contract amount in or before the 11th month of operation.
