 1.2 relating to human services; repealing the TEFRA monetary parental contribution;
 1.3 amending Minnesota Statutes 2014, sections 13.46, subdivision 2; 246.511;
 1.4 252.27, subdivisions 1, 2a, 3; 270B.14, subdivision 1; repealing Minnesota
 1.5 Statutes 2014, section 252.27, subdivisions 2, 2b, 4a, 5, 6.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2014, section 13.46, subdivision 2, is amended to read:

1.8 Subd. 2. **General.** (a) Data on individuals collected, maintained, used, or
 1.9 disseminated by the welfare system are private data on individuals, and shall not be
 1.10 disclosed except:

- 1.11 (1) according to section 13.05;
- 1.12 (2) according to court order;
- 1.13 (3) according to a statute specifically authorizing access to the private data;
- 1.14 (4) to an agent of the welfare system and an investigator acting on behalf of a county,
 1.15 the state, or the federal government, including a law enforcement person or attorney in the
 1.16 investigation or prosecution of a criminal, civil, or administrative proceeding relating to
 1.17 the administration of a program;
- 1.18 (5) to personnel of the welfare system who require the data to verify an individual's
 1.19 identity; determine eligibility, amount of assistance, and the need to provide services to
 1.20 an individual or family across programs; evaluate the effectiveness of programs; assess
 1.21 parental contribution amounts; and investigate suspected fraud;
- 1.22 (6) to administer federal funds or programs;
- 1.23 (7) between personnel of the welfare system working in the same program;
- 1.24 (8) to the Department of Revenue to assess ~~parental contribution amounts for~~
 1.25 ~~purposes of section 252.27, subdivision 2a~~, administer and evaluate tax refund or tax credit

2.1 programs and to identify individuals who may benefit from these programs. The following
2.2 information may be disclosed under this paragraph: an individual's and their dependent's
2.3 names, dates of birth, Social Security numbers, income, addresses, and other data as
2.4 required, upon request by the Department of Revenue. Disclosures by the commissioner
2.5 of revenue to the commissioner of human services for the purposes described in this clause
2.6 are governed by section 270B.14, subdivision 1. Tax refund or tax credit programs include,
2.7 but are not limited to, the dependent care credit under section 290.067, the Minnesota
2.8 working family credit under section 290.0671, the property tax refund and rental credit
2.9 under section 290A.04, and the Minnesota education credit under section 290.0674;

2.10 (9) between the Department of Human Services, the Department of Employment
2.11 and Economic Development, and when applicable, the Department of Education, for
2.12 the following purposes:

2.13 (i) to monitor the eligibility of the data subject for unemployment benefits, for any
2.14 employment or training program administered, supervised, or certified by that agency;

2.15 (ii) to administer any rehabilitation program or child care assistance program,
2.16 whether alone or in conjunction with the welfare system;

2.17 (iii) to monitor and evaluate the Minnesota family investment program or the child
2.18 care assistance program by exchanging data on recipients and former recipients of food
2.19 support, cash assistance under chapter 256, 256D, 256J, or 256K, child care assistance
2.20 under chapter 119B, or medical programs under chapter 256B, 256D, or 256L; and

2.21 (iv) to analyze public assistance employment services and program utilization,
2.22 cost, effectiveness, and outcomes as implemented under the authority established in Title
2.23 II, Sections 201-204 of the Ticket to Work and Work Incentives Improvement Act of
2.24 1999. Health records governed by sections 144.291 to 144.298 and "protected health
2.25 information" as defined in Code of Federal Regulations, title 45, section 160.103, and
2.26 governed by Code of Federal Regulations, title 45, parts 160-164, including health care
2.27 claims utilization information, must not be exchanged under this clause;

2.28 (10) to appropriate parties in connection with an emergency if knowledge of
2.29 the information is necessary to protect the health or safety of the individual or other
2.30 individuals or persons;

2.31 (11) data maintained by residential programs as defined in section 245A.02 may
2.32 be disclosed to the protection and advocacy system established in this state according
2.33 to Part C of Public Law 98-527 to protect the legal and human rights of persons with
2.34 developmental disabilities or other related conditions who live in residential facilities for
2.35 these persons if the protection and advocacy system receives a complaint by or on behalf

3.1 of that person and the person does not have a legal guardian or the state or a designee of
3.2 the state is the legal guardian of the person;

3.3 (12) to the county medical examiner or the county coroner for identifying or locating
3.4 relatives or friends of a deceased person;

3.5 (13) data on a child support obligor who makes payments to the public agency
3.6 may be disclosed to the Minnesota Office of Higher Education to the extent necessary to
3.7 determine eligibility under section 136A.121, subdivision 2, clause (5);

3.8 (14) participant Social Security numbers and names collected by the telephone
3.9 assistance program may be disclosed to the Department of Revenue to conduct an
3.10 electronic data match with the property tax refund database to determine eligibility under
3.11 section 237.70, subdivision 4a;

3.12 (15) the current address of a Minnesota family investment program participant
3.13 may be disclosed to law enforcement officers who provide the name of the participant
3.14 and notify the agency that:

3.15 (i) the participant:

3.16 (A) is a fugitive felon fleeing to avoid prosecution, or custody or confinement after
3.17 conviction, for a crime or attempt to commit a crime that is a felony under the laws of the
3.18 jurisdiction from which the individual is fleeing; or

3.19 (B) is violating a condition of probation or parole imposed under state or federal law;

3.20 (ii) the location or apprehension of the felon is within the law enforcement officer's
3.21 official duties; and

3.22 (iii) the request is made in writing and in the proper exercise of those duties;

3.23 (16) the current address of a recipient of general assistance or general assistance
3.24 medical care may be disclosed to probation officers and corrections agents who are
3.25 supervising the recipient and to law enforcement officers who are investigating the
3.26 recipient in connection with a felony level offense;

3.27 (17) information obtained from food support applicant or recipient households may
3.28 be disclosed to local, state, or federal law enforcement officials, upon their written request,
3.29 for the purpose of investigating an alleged violation of the Food Stamp Act, according
3.30 to Code of Federal Regulations, title 7, section 272.1(c);

3.31 (18) the address, Social Security number, and, if available, photograph of any
3.32 member of a household receiving food support shall be made available, on request, to a
3.33 local, state, or federal law enforcement officer if the officer furnishes the agency with the
3.34 name of the member and notifies the agency that:

3.35 (i) the member:

4.1 (A) is fleeing to avoid prosecution, or custody or confinement after conviction, for a
4.2 crime or attempt to commit a crime that is a felony in the jurisdiction the member is fleeing;

4.3 (B) is violating a condition of probation or parole imposed under state or federal
4.4 law; or

4.5 (C) has information that is necessary for the officer to conduct an official duty related
4.6 to conduct described in subitem (A) or (B);

4.7 (ii) locating or apprehending the member is within the officer's official duties; and

4.8 (iii) the request is made in writing and in the proper exercise of the officer's official
4.9 duty;

4.10 (19) the current address of a recipient of Minnesota family investment program,
4.11 general assistance, general assistance medical care, or food support may be disclosed to
4.12 law enforcement officers who, in writing, provide the name of the recipient and notify the
4.13 agency that the recipient is a person required to register under section 243.166, but is not
4.14 residing at the address at which the recipient is registered under section 243.166;

4.15 (20) certain information regarding child support obligors who are in arrears may be
4.16 made public according to section 518A.74;

4.17 (21) data on child support payments made by a child support obligor and data on
4.18 the distribution of those payments excluding identifying information on obligees may be
4.19 disclosed to all obligees to whom the obligor owes support, and data on the enforcement
4.20 actions undertaken by the public authority, the status of those actions, and data on the
4.21 income of the obligor or obligee may be disclosed to the other party;

4.22 (22) data in the work reporting system may be disclosed under section 256.998,
4.23 subdivision 7;

4.24 (23) to the Department of Education for the purpose of matching Department of
4.25 Education student data with public assistance data to determine students eligible for free
4.26 and reduced-price meals, meal supplements, and free milk according to United States
4.27 Code, title 42, sections 1758, 1761, 1766, 1766a, 1772, and 1773; to allocate federal and
4.28 state funds that are distributed based on income of the student's family; and to verify
4.29 receipt of energy assistance for the telephone assistance plan;

4.30 (24) the current address and telephone number of program recipients and emergency
4.31 contacts may be released to the commissioner of health or a community health board as
4.32 defined in section 145A.02, subdivision 5, when the commissioner or community health
4.33 board has reason to believe that a program recipient is a disease case, carrier, suspect case,
4.34 or at risk of illness, and the data are necessary to locate the person;

4.35 (25) to other state agencies, statewide systems, and political subdivisions of this
4.36 state, including the attorney general, and agencies of other states, interstate information

5.1 networks, federal agencies, and other entities as required by federal regulation or law for
5.2 the administration of the child support enforcement program;

5.3 (26) to personnel of public assistance programs as defined in section 256.741, for
5.4 access to the child support system database for the purpose of administration, including
5.5 monitoring and evaluation of those public assistance programs;

5.6 (27) to monitor and evaluate the Minnesota family investment program by
5.7 exchanging data between the Departments of Human Services and Education, on
5.8 recipients and former recipients of food support, cash assistance under chapter 256, 256D,
5.9 256J, or 256K, child care assistance under chapter 119B, or medical programs under
5.10 chapter 256B, 256D, or 256L;

5.11 (28) to evaluate child support program performance and to identify and prevent
5.12 fraud in the child support program by exchanging data between the Department of Human
5.13 Services, Department of Revenue under section 270B.14, subdivision 1, paragraphs (a)
5.14 and (b), without regard to the limitation of use in paragraph (c), Department of Health,
5.15 Department of Employment and Economic Development, and other state agencies as is
5.16 reasonably necessary to perform these functions;

5.17 (29) counties operating child care assistance programs under chapter 119B may
5.18 disseminate data on program participants, applicants, and providers to the commissioner
5.19 of education; or

5.20 (30) child support data on the child, the parents, and relatives of the child may be
5.21 disclosed to agencies administering programs under titles IV-B and IV-E of the Social
5.22 Security Act, as authorized by federal law.

5.23 (b) Information on persons who have been treated for drug or alcohol abuse may
5.24 only be disclosed according to the requirements of Code of Federal Regulations, title
5.25 42, sections 2.1 to 2.67.

5.26 (c) Data provided to law enforcement agencies under paragraph (a), clause (15),
5.27 (16), (17), or (18), or paragraph (b), are investigative data and are confidential or protected
5.28 nonpublic while the investigation is active. The data are private after the investigation
5.29 becomes inactive under section 13.82, subdivision 5, paragraph (a) or (b).

5.30 (d) Mental health data shall be treated as provided in subdivisions 7, 8, and 9, but are
5.31 not subject to the access provisions of subdivision 10, paragraph (b).

5.32 For the purposes of this subdivision, a request will be deemed to be made in writing
5.33 if made through a computer interface system.

5.34 Sec. 2. Minnesota Statutes 2014, section 246.511, is amended to read:

5.35 **246.511 RELATIVE RESPONSIBILITY.**

6.1 Except for chemical dependency services paid for with funds provided under chapter
 6.2 254B, a client's relatives shall not, pursuant to the commissioner's authority under
 6.3 section 246.51, be ordered to pay more than the following: (1) for services provided in a
 6.4 community-based service, the noncovered cost of care as determined under the ability to
 6.5 pay determination; and (2) for services provided at a regional treatment center operated
 6.6 by state-operated services, 20 percent of the cost of care, unless they reside outside the
 6.7 state. Parents of children in state facilities shall have their responsibility to pay determined
 6.8 according to section 252.27, subdivision ~~2~~ 2a, or in rules adopted under chapter 254B if
 6.9 the cost of care is paid under chapter 254B. The commissioner may accept voluntary
 6.10 payments in excess of 20 percent. The commissioner may require full payment of the full
 6.11 per capita cost of care in state facilities for clients whose parent, parents, spouse, guardian,
 6.12 or conservator do not reside in Minnesota.

6.13 Sec. 3. Minnesota Statutes 2014, section 252.27, subdivision 1, is amended to read:

6.14 Subdivision 1. **County of financial responsibility.** Whenever any child who has a
 6.15 developmental disability, or a physical disability or emotional disturbance is in 24-hour
 6.16 care outside the home including respite care, in a facility licensed by the commissioner
 6.17 of human services, the cost of services shall be: (1) paid by the county of financial
 6.18 responsibility determined pursuant to chapter 256G; (2) covered by medical assistance
 6.19 if the child is eligible; or (3) covered by other health coverage. If the child's parents or
 6.20 guardians do not reside in this state, the cost shall be paid by the responsible governmental
 6.21 agency in the state from which the child came, by the parents or guardians of the child if
 6.22 they are financially able, or, if no other payment source is available, by the commissioner
 6.23 of human services.

6.24 Sec. 4. Minnesota Statutes 2014, section 252.27, subdivision 2a, is amended to read:

 9.22 including medical assistance, the attorney general, at the request of the commissioner,
 9.23 may institute or direct the appropriate county attorney to institute civil action to recover

252.27 CHILDREN'S SERVICES; PARENTAL CONTRIBUTION.

Subd. 2. **Parental responsibility.** Responsibility of the parents for the cost of services shall be based upon ability to pay. The state agency shall adopt rules to determine responsibility of the parents for the cost of services when:

- (1) insurance or other health care benefits pay some but not all of the cost of services; and
- (2) no insurance or other health care benefits are available.

Subd. 2b. **Child's responsibility.** Responsibility of the child for the cost of care shall be up to the maximum amount of the total income and resources attributed to the child except for the clothing and personal needs allowance as provided in section 256B.35, subdivision 1. Reimbursement by the parents and child shall be made to the county making any payments for services. The county board may require payment of the full cost of caring for children whose parents or guardians do not reside in this state.

To the extent that a child described in subdivision 1 is eligible for benefits under chapter 62A, 62C, 62D, 62E, or 64B, the county is not liable for the cost of services.

Subd. 4a. **Order of payment.** If the parental contribution is for reimbursement for the cost of services to both the local agency and the medical assistance program, the local agency shall be reimbursed for its expenses first and the remainder must be deposited in the medical assistance account.

Subd. 5. **Determination; redetermination; notice.** A determination order and notice of parental fee shall be mailed to the parent at least annually, or more frequently as provided in Minnesota Rules, parts 9550.6220 to 9550.6229. The determination order and notice shall contain the following information:

- (1) the amount the parent is required to contribute;
- (2) notice of the right to a redetermination and appeal; and
- (3) the telephone number of the division at the Department of Human Services that is responsible for redeterminations.

Subd. 6. **Appeals.** A parent may appeal the determination or redetermination of an obligation to make a contribution under this section, according to section 256.045. The parent must make a request for a hearing in writing within 30 days of the date the determination or redetermination order is mailed, or within 90 days of such written notice if the parent shows good cause why the request was not submitted within the 30-day time limit. The commissioner must provide the parent with a written notice that acknowledges receipt of the request and notifies the parent of the date of the hearing. While the appeal is pending, the parent has the rights regarding making payment that are provided in Minnesota Rules, part 9550.6235. If the commissioner's determination or redetermination is affirmed, the parent shall, within 90 calendar days after the date an order is issued under section 256.045, subdivision 5, pay the total amount due from the effective date of the notice of determination or redetermination that was appealed by the parent. If the commissioner's order under this subdivision results in a decrease in the parental fee amount, any payments made by the parent that result in an overpayment shall be credited to the parent as provided in Minnesota Rules, part 9550.6235, subpart 3.
