1.8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.9	Section 1. [115A.413] SOLID WASTE FACILITIES AND SITES; RULEMAKING.
1.10	Revisions to criteria and standards that govern siting, constructing, or operating solid
1.11	waste facilities or solid waste facility sites are subject to the rulemaking provisions of chapter
1.12	<u>14.</u>
1.13	EFFECTIVE DATE. This section is effective the day following final enactment.
1.14	Sec. 2. Minnesota Statutes 2016, section 473.149, subdivision 1, is amended to read:
1.15	Subdivision 1. Policy plan; general requirements. (a) The commissioner of the Pollution
1.16	Control Agency shall revise the metropolitan long range policy plan for solid waste
1.17	management adopted in 2011 by December 31, 2016, and every sixth year thereafter. The
1.18	plan shall be followed in the metropolitan area consider costs imposed on consumers and
1.19	businesses and potential negative impacts on the private solid waste industry. The plan shall
1.20	address the state policies and purposes expressed in section 115A.02. In revising the plan
1.21	the commissioner shall follow the procedures in subdivision 3. The plan shall include goals
1.22	and policies for solid waste management, including recycling consistent with section

2.1 115A.551, and household hazardous waste management consistent with section 115A.96,

The plan shall, to the extent 2.6 practicable and consistent with the achievement of other public policies and purposes, 2.7 encourage ownership and operation of solid waste facilities by private industry. For solid 2.8 waste facilities owned or operated by public agencies or supported primarily by public funds 2.9 or obligations issued by a public agency, the plan shall include additional criteria and 2.10 standards to protect comparable private and public facilities already existing in the area 2.11 from displacement unless the displacement is required in order to achieve the waste 2.12 management objectives identified in the plan. In revising the plan, the commissioner shall 2.13 consider the orderly and economic development, public and private, of the metropolitan 2.14 area; the preservation and best and most economical use of land and water resources in the 2.15 metropolitan area; the protection and enhancement of environmental quality; the conservation 2.16 and reuse of resources and energy; the preservation and promotion of conditions conducive 2.17 to efficient, competitive, and adaptable systems of waste management; and the orderly 2.18 resolution of questions concerning changes in systems of waste management. Criteria and 2.19 standards for solid waste facilities shall be consistent with rules adopted by the Pollution 2.20 Control Agency pursuant to chapter 116 and shall be at least as stringent as the guidelines, 2.21 regulations, and standards of the federal Environmental Protection Agency. 2.22

Subd. 3. **Preparation; adoption; and revision.** (a) The solid waste policy plan shall be prepared, adopted, and revised as necessary in accordance with paragraphs (c) to (e) (b) to (d), after consultation with the metropolitan counties.

- 2.28 (b) Revisions to the policy plan are exempt from the rulemaking provisions of chapter
 2.29 14.
- (c) Before beginning preparation of revisions to the policy plan, the commissioner shall
 publish a predrafting notice in the State Register that includes a statement of the subjects
 expected to be covered by the revisions, including a summary of the important problems
 and issues. The notice must solicit comments from the public and state that the comments

- must be received by the commissioner within 45 days of publication of the notice. The
 commissioner shall consider the comments in preparing the revisions.
- 3.3 (d) (c) After publication of the predrafting notice and before adopting revisions to the

The court may declare the challenged portion of the policy 3.26 3.27 plan invalid if it violates constitutional provisions, is in excess of statutory authority of the commissioner, or was adopted without compliance with the procedures in this subdivision. 3.28 The review shall be on the record created during the adoption of the policy plan, except that 3.29 additional evidence may be included in the record if the court finds that the additional 3.30 evidence is material and there were good reasons for failure to present it in the proceedings 3.31 described in paragraphs (c) to (c) (b) to (d). 3.32

(f) The Metropolitan Council or a metropolitan county, local government unit,

Subdivision 1. County acquisition of facilities. To accomplish the purpose specified 5.10 5.11 in section 473.803, each metropolitan county may acquire by purchase, lease, gift, or condemnation as provided by law, upon such terms and conditions as it shall determine, 5.12 including contracts for deed and conditional sales contracts, solid waste facilities or properties 5.13 or easements for solid waste facilities which that are in accordance with rules adopted by 5.14 the agency, the policy plan and the approved county master plan, and may improve or 5.15 5.16 construct improvements on any property or facility so acquired. No metropolitan city, county or town shall own or operate a hazardous waste facility, except a facility to manage household 5.17 hazardous waste. Each metropolitan county is authorized to levy a tax in anticipation of 5.18 need for expenditure for the acquisition and betterment of solid waste facilities. If a tax is 5.19 levied in anticipation of need, the purpose must be specified in a resolution of the county 5.20 directing that the levy and the proceeds of the tax may be used only for that purpose. Until 5.21 so used, the proceeds shall be retained in a separate fund or invested in the same manner as 5.22 surplus in a sinking fund may be invested under section 118A.04. Except as provided in this subdivision, a county may establish and operate or contract for 6.1 the establishment or operation of a solid waste disposal facility without complying with 6.2 local ordinances if the commissioner certifies need under section 473.823, subdivision 6. 6.3 With the approval of the commissioner, local government units may impose and enforce 6.4 reasonable conditions respecting the construction, operation, inspection, monitoring, and 6.5 maintenance of the disposal facilities. Subd. 3. Solid waste facilities; review procedures. (a) The agency shall request 6.13 applicants for solid waste facility permits to submit all information deemed relevant by the 6.14 commissioner for review, including without limitation information relating to the geographic 6.15 6.16 areas and population served, the need, the effect on existing facilities and services, the effectiveness of proposed buffer areas to ensure, at a minimum, protection of surrounding 6.17 land uses from adverse or incompatible impacts due to landfill operation and related activities, 6.18 the anticipated public cost and benefit, the anticipated rates and charges, the manner of 6.19 financing, the effect on metropolitan plans and development programs, the supply of waste, 6.20 anticipated markets for any product, and alternative means of disposal or energy production. 6.21

(b) A permit may not be issued for the operation of a solid waste facility in the 6.22 metropolitan area which is not in accordance with the metropolitan policy plan. The 6.23 commissioner shall determine whether a permit is in accordance with the policy plan. In 6.24 making this determination evaluating a permit application, the commissioner shall consider 6.25 the areawide need and benefit of the applicant facility and the effectiveness of proposed 6.26 buffer areas to adequately protect surrounding land uses in accordance with the policy plan, 6.27 6.28 and may consider, without limitation, the effect of the applicant facility on existing and planned solid waste facilities. 6.29

(c) If the commissioner determines that a permit is in accordance with the policy plan,
the commissioner shall approve the permit. If the commissioner determines that a permit
is not in accordance with the policy plan, the commissioner shall disapprove the permit.
Approval of permits may be subject to conditions the commissioner determines are necessary
to satisfy criteria and standards in the policy plan, including conditions respecting the type,

character, and quantities of waste to be processed at a solid waste facility used primarily

for resource recovery and the geographic territory from which a resource recovery facility
or transfer station serving such a facility may draw its waste.

(d) A permit may not be issued in the metropolitan area for a solid waste facility used 7.4 primarily for resource recovery or a transfer station serving the facility, if the facility or 7.5 station is owned or operated by a public agency or if the acquisition or betterment of the 7.6 facility or station is secured by public funds or obligations issued by a public agency, unless 7.7 the commissioner finds and determines that adequate markets exist for the products recovered 7.8 and that establishment of the facility is consistent with the criteria and standards in the 7.9 metropolitan and county plans respecting the protection of existing resource recovery 7.10 facilities and transfer stations serving such facilities. 7.11
