The bill was read for the first time and referred to the Committee on State Government Finance and Veterans Affairs

1.1 A bill for an act
 1.2 relating to capital investment; appropriating money for renovation of the
 1.3 Brooklyn Park Armory; authorizing the sale and issuance of state bonds.
 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **BROOKLYN PARK ARMORY.**

1.6 Subdivision 1. **Appropriation.** \$1,244,000 is appropriated from the bond proceeds
 1.7 fund to the adjutant general to renovate, furnish, and equip the Brooklyn Park Armory.

1.8 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the
 1.9 bond proceeds fund, the commissioner of management and budget shall sell and issue
 1.10 bonds of the state in an amount up to \$1,244,000 in the manner, upon the terms, and with
 1.11 the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the
 1.12 Minnesota Constitution, article XI, sections 4 to 7.

1.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.
